Leachco will call the following witnesses at the Hearing:



2. **Peggy Shibata.** Pursuant to 16 C.F.R. Pt. 1024.44(b), Ms. Shibata's direct testimony is set forth in her April 28, 2023 Report, which was filed and served on that date. Leachco reserves the right to conduct re-direct examination upon the CPSC's cross-examination.
3. **Umakanth Katwa.** (upon cross-examination). The CPSC has offered Dr. Katwa's April 28, 2023 Report as expert testimony. Pursuant to 16 C.F.R. Pt. 1025.44, Leachco will cross-examine and, if necessary, conduct re-cross-examination of Dr. Katwa.
4. **Celestine Kish.** (upon cross-examination). The CPSC has offered Ms. Kish's May 2, 2023 Corrected Report as expert testimony. Pursuant to 16 C.F.R. Pt. 1025.44, Leachco will cross-examine and, if necessary, conduct re-cross-examination of Ms. Kish.
5. **Erin Mannen.** (upon cross-examination). The CPSC has offered Dr. Mannen's April 28, 2023 Report as expert testimony. Pursuant to 16 C.F.R. Pt. 1025.44, Leachco will cross-examine and, if necessary, conduct re-cross-examination of Dr. Mannen.

Leachco may call the following witnesses at the Hearing:

1. **Alex Leach.** If called, Mr. Leach, the COO of Leachco, would testify about the founding and history of Leachco, the Podster, and the harm caused to Leachco by the CPSC's unilateral announcement that the Podster is a hazardous product. Mr. Leach may also be called as a rebuttal witness.
2. **Clyde Leach.** Mr. Leach may be called as a rebuttal witness.
3. **Mabry Ballard.** Ms. Ballard, an employee of Leachco, may be called as a rebuttal witness.
4. **Tonya Barrett.** Ms. Barrett, an employee of Leachco, may be called as a rebuttal witness.
5. **Leah Barnes.** Ms. Barnes, a former employee of Leachco, may be called as a rebuttal witness.
6. **Zachary Foster.** Mr. Foster is an employee of the CPSC. If called, Mr. Foster would be asked about the CPSC's procedures and practices concerning the investigation and analysis of potentially hazardous products, and his analysis of the Podster. Mr. Foster may also be called as a rebuttal witness.
7. **Hope Nesteruk.** Ms. Nesteruk is an employee of the CPSC. If called, Ms. Nesteruk would be asked about the CPSC's procedures and practices concerning the investigation and analysis of potentially hazardous products, and her analysis of the Podster. Ms. Nesteruk may also be called as a rebuttal witness.
8. **Suad Wanna-Nakamura.** Dr. Wanna-Nakamura is an employee of the CPSC. If called, Dr. Wanna-Nakamura would be asked about the CPSC's procedures and practices concerning the investigation and analysis of potentially hazardous products, and her analysis of the Podster. Dr. Wanna-Nakamura may also be called as a rebuttal witness.
9. **Celestine Kish.** Ms. Kish is an employee of the CPSC. If called, Ms. Kish would be asked about the CPSC's procedures and practices concerning the investigation and analysis of potentially hazardous products, and her pre-complaint analysis of infant products and the Podster. Ms. Kish may also be called as a rebuttal witness.
