SUMMARY:

The victim's mother was contacted upon receipt of the assignment. She readily agreed to an on-site investigation. Upon arrival at the complainant's home, I was informed by the victim's father that since my initial phone call to arrange for an on-site, a lawyer had advised them not to provide any information to CPSC because the family is considering a lawsuit against the manufacturer. According to the complaint report, the victim's mother placed the seat in the tub per the product's instructions. She then put the victim in the chair (baby sitter). When she finished bathing her daughter, she (victim's mother) turned away for a second. When she turned back around, she found the child had drowned. The suction cups on the chair had come undone and caused the child and chair to overturn. The complainant, the victim's mother, would not comment on information provided when the complaint was filed. I was permitted to photograph the accident scene and the product. (See Exhibits for details) I was not permitted to obtain the product from the complainant as a sample.

An unofficial sample was collected from the store where the product involved in the accident was purchased. The product was purchased from Super-Saver Wholesale Warehouse, 1100 Beltline Highway, Mobile, Alabama (205)344-6491. According to Mr. Charles Lanclos, Assistant Manager, the store opened on July 18, 1985, and since that time has sold 240 units of the product. According to Mr. Lanclos, the store had not received any complaints regarding the product.

Size/Dimensions: The product is approximately 6" in height. It is a device designed to retain and support the infant in a sitting position while seated inside a circular hoop rail with 4 vertical legs. Each leg is approximately 6 1/4" apart and has a large suction cup attached to it. A soft matching yellow sponge seat, contoured to add to the baby's comfort and prevent slipping and sliding, comes with the product. The diameter of the hoop rail is approximately 1 1/2", and the diameter of the loop is approximately 9". The diameter of the suction cups is approximately 2-5/8", and height of each suction cup is 2 1/4". Each suction cup bears raised letter markings which read, "BABY ~~SITTER~~ TM PAT. No. 223263." The top of the hoop rail bears black raised letter markings which reads as follows: "WARNING: DO NOT LEAVE CHILD UNATTENDED."





View of product showing distance between the tubular legs.







Full view of product with sponge seat.



SUBJECT : External Examination

Under the authorization of the Mobile County Coroner's Office and under the provisions of Alabama Code No. 36-18-2 an external examination is performed upon the body identified as Carrie Barjenbruch. The examination is conducted at the Alabama Department of Forensic Sciences Mobile Laboratory on Sunday, September 8, 1985, beginning at 1500 hours, CDT. Mr. Michael Agnew of the Department of Forensic Sciences is assistant to the examination.

DESCRIPTION OF FINDINGS: The body is that of a normally developed, unembalmed, white female infant measuring 24 inches in the crown-heel length, 18 inches in the crown-rump length, weighing 19 pounds and appearing the reported age of seven months.

CLOTHING: The body is received with a green multipatterned with children and toys hospital gown.

EVIDENCE OF RESUSCITATION AND HOSPITAL MAINTENANCE MEASURES: There is evidence of extensive resuscitation and hospital maintenance measures. There is an endotracheal tube in the right side of the mouth, an intravenous infusion set in the right infraclavicular region, another one in the left infraclavicular

region. There is a cutdown incision with a vascular infusion set in the region of the left radial artery. This region is covered with a bandage. There are two chest tubes in the right lateral surface of the chest, one on the left side. Both of these are covered with bandages. There is a Foley catheter in a urethra. There is a 1 cm cutdown incision on the medial surface of the right ankle. There are multiple needle puncture marks in the inguinal regions. There are a few needle puncture marks over the scalp. There is a hospital identification band on the right ankle. There is a paper diaper present.

HEAD AND FACIES: The head measures 17-1/2 inches in circumference. The anterior fontanelle is patent to palpation. There is a 1 cm in greatest dimension ecchymoses in the left frontoparietal region. There are small needle puncture marks present. The scalp is covered with 1/2 to 1 inch long very fine blonde hair.

EYES: The pupils are widely dilated 5 mm; irides dark blue; conjunctivae pale with no hemorrhages.

NOSE: Nares patent; no injuries.

ORAL CAVITY: There are no injuries to the mucosa. The alveolar ridges are edentulous.

EARS: Normally formed; no injuries.

NECK: Symmetrical; no injuries.

CHEST: There are no injuries other than resuscitation. The chest measures 17 inches in circumference at the nipple line.

ABDOMEN: Protuberant; no injuries, other than resuscitation. The abdomen measures 17 inches in circumference at the umbilicus.

PELVIS AND EXTERNAL GENITALIA: There are no injuries other than those of resuscitation. The labia majorum are edematous and are hyperemic.

LOWER EXTREMITIES: Very chubby; slight edema. There are some ecchymoses in the extensor surface of the right ankle. All digits are present.

UPPER EXTREMITIES: There are small petechial hemorrhages present. There are multiple needle puncture marks in the region

of both radial arteries and a 1 cm cutdown incision in the region of the left radial artery. All digits are present; normally formed.

BACK: Symmetrical; no injuries.

EVIDENCE OF MAJOR TRAUMA: There is no evidence of mechanical trauma to the body.

CAUSE OF DEATH: Complications of submersion.

Nursery Products

I. Introduction

A. Background Information

Nursery product-related injuries appear to be increasing in frequency. While the absolute number of such injuries is not great in comparison with many other products, it must be considered that almost all of the injuries are to children less than 5 years-of-age. Most are to infants under 2 years old. When the small population at risk is considered, the injury rates associated with these products are large. Among children's products, more injuries and deaths to children less than 5 years-of-age involved nursery products than any other group of products.

There is an active and safety conscious trade association for makers of nursery products. Several voluntary standards have been undertaken and our support, through evaluation of these standards and identification of areas for new standards, can result in a good cooperative effort to reduce injuries.

B. Product Class Description

1. Definitions and General Description

Includes all nursery furniture and products used in the care of infants, e.g., changing tables, strollers, pacifiers, disposable diapers, cribs, rattles, high chairs, baby walkers, etc.

Information provided in this report was supplied by the medical examiner's office who would not permit contact with the parents. The responding police department did not wish to cooperate in this investigation.

PRE-ACCIDENT

The victim in this incident was a 6 month old female, DOB 8/18/96. Height and weight are 4-1/8" and 19 lbs., respectively. The victim, her mother and older sister were staying at the home of the victim's grandmother, however, since this is not the child's listed address, it is unknown why or how long they had been staying in a residence that was not their own. What is known is that on the day of the accident, 3/9/97 at approximately 6:00 p.m., the mother was giving the 6 month old victim a bath in the bathroom of this residence.

According to information provided by the responding police to the medical examiner, the mother stated that she had filled the tub with approximately 6 inches of water, placed an infant bath seat in the tub and placed her child in the seat to bathe her. The mother stated that the bath seat had rubber suction cups on the bottom which was supposed to adhere the seat to the tub's surface, thus allowing the child to sit upright to be bathed. The mother admitted that the suction cups did not stick. It is unknown if and when the bath seat was purchased or if it was new or used and what conditions existed which allowed the suction cups not to stick to the bottom of the tub. The mother stated that while she was bathing the victim, the telephone rang and she went to answer it.

ACCIDENT

While the mother was on the telephone, she heard her older child screaming and she returned to the bathroom to find the 6 month old victim lying on her back with her face under the surface of the water. The child was still in the bath seat.

POST ACCIDENT

The mother removed the child and called "911". The local emergency medical service arrived and began resuscitative efforts and transported the victim to the local hospital. The child was then transported to Children's Hospital, Philadelphia, PA where she expired on 3/10/97.

According to the medical examiner's investigator, the responding police department collected the bath seat for photographic purposes and then was going to forward the seat to them. However, the M.E.'s office has not received the bath seat to date.

PRODUCT IDENTIFICATION

The product involved in this accident was a "Gerry Splash Seat" which is a bath seat designed for bathing infants in a conventional bathtub. The bath seat, according to the medical examiner's report, is constructed of plastic and has four suction cups on the bottom which is supposed to adhere to the porcelain surface of the tub to ensure that the child would not float or tipover in the water. According to the M.E.'s office, the mother related that the suction cups did not work properly. No other information is available concerning the bath seat.



6. SYNOPSIS OF ACCIDENT OR COMPLAINT
 Inexperienced 18 year old female babysitter allowed a 8 month old female baby to sit unattended in a bathtub inside a plastic yellow bathing ring for approximately 1 hour. The ring was equipped with 4 legs inserted into suction cups. There was a warning on the ring. There was approximately 9-11 inches of water in the tub. There were plastic and sponge toys in the tub also. Baby was found by sitter floating in tub. She removed baby and applied mouth to mouth resuscitation. Baby declared dead at scene by medical examiner. Autopsy performed, copy attached.

24. NARRATIVE (See instructions on Other Side) Upon advice of surviving parents counsel, no visit was made to actual site nor were parents and babysitter interviewed in person. Epidemiological information furnished by attorney, police report, police interview of babysitter and autopsy report.

An 18 year old female live-in babysitter gave a 7 month old baby a bath and left her unattended for approximately one hour while she attended to two other children, making lunch for them and attending to their needs. She admitted this was her first experience taking care of the children alone and only the second time she had given the baby a bath, both on the same day. She placed the baby in a yellow plastic ring attached to the bottom of the bath tub by 4 legs inserted into suction cups. The babysitter had been living in the home for approximately a month prior to the accident. According to a police interview she left the baby in the tub from approximately 1 p.m. to 2:10 p.m. She stated she checked on the child at 1:35 p.m. and said she was all right. She said she heard splashing and assumed the baby was all right. There were plastic and sponge rubber toys in the tub surrounding the yellow ring. There was approximately 9 to 11 inches of water in the tub. She stated she found the baby floating in the tub at 2:10 p.m. She removed the baby to a nearby bed and applied mouth to mouth resuscitation. She called her mother and asked her to come over.

Several other people also arrived. The parents and police were notified. The baby was pronounced dead at the scene and removed to the hospital for an autopsy, a copy of which is attached.

The product involved is called "The Baby Sitter" and manufactured by A-Plus Products, Inc. of 8780 National Boulevard, Culver, CA 90232. It is made of hard yellow plastic. It has 4 legs with suction cups attached. It has raised embossed letters, painted black, stating "Warning - Do Not Leave Child Unattended" on the top of the ring. It was purchased at a local Meijer Thrifty Acre store. The original carton and instructions were disposed of shortly after purchase. A similar unit purchased by the attorney for the parents had a sponge seat included. The carton contains a statement "for babies from 6 months." The ring remained attached to the tub during this incident. The accompanying pictures are of the actual ring used, but the pictures of the container are not of the original carton.



Narrative

C.S.T. Laemmel photographed the scene with color film, C.S.T. Saur with polaroid. Photos included location of the baby on the bed in southwest bedroom, the bathtub and contents, and general condition of the south bedrooms and bathroom. C.S.T. Saur sketched the scene, with Laemmel assisting with measurements. Collected from the west side of the bed, a sample of unknown white colored powdery substance, which was wet. From the east side of the bed, collected another sample of white, wet powdery substance and a wooden paddle. Collected from the bathtub a yellow, four-legged plastic baby seat (approx. 10" in diameter and 5 1/2" tall), with suction cups on the bottoms of the legs. John Connolly, Medical Examiner responded to the scene, and the body was transported to Blodgett Hosp. by Dick Washburn of Verhev Transfer. An autopsy is scheduled for 11/7/86 at 0900hrs. Officers present upon our arrival were Adams #15, V. Kuiper #62 and Sgt. Rawley #516. MGT members Williams #12 and Kooistra #60 also responded to the scene. At 1550hrs, C.S.T. Laemmel went to Blodgett Hospital, and placed a tag identifying the body on the right big toe of the victim, a W/F, age 3mos., named [REDACTED]

HISTORY: This 8 month old white female infant was found submerged in the bathtub by her babysitter at about 2:20 pm on 11/6/86. She allegedly had put the child in the bathtub between 1:20 and 2:00 pm. She claimed that the child was placed in a yellow plastic ring with suction cups on the bottom. At the scene the child was warm without livor mortis or rigidity. She had been removed from the tub. There were 10-12 inches of water in the tub.

IDENTIFICATION: By toe tag. Foot prints are taken.

EXTERNAL EXAMINATION: The body is that of a normally developed white female infant of average build consistent with the stated age of 8 months and measuring 30 inches (76.2 cm). The body is normally nourished and weighs 20 1/2 pounds (9.3 kg).

There is good preservation in the absence of embalming. There is well developed posterior lividity which is normal in color. There is full rigidity and the body is cool after refrigeration.

The hairline is normal. The head hair is normal in amount, straight, blonde, and measures 2 1/2 inches. The body hair is fine and downy. The scalp, ears, nose, mouth, face and neck are normally formed. The eyes are closed. The corneas are clear. The irides are brown. The pupils are round and equal. No petechial hemorrhages are seen within the conjunctiva. The ears are not pierced. The mouth contains two lower incisors and no other teeth. The frenula of the upper and lower lips are intact. There is no injury to the buccal surface of the mouth. The neck is symmetrical. The chest is symmetrical. The abdomen is slightly protuberant. The limbs are equally and symmetrically developed. The genitalia are those of a normal infant female. The back and buttocks are intact.

hemorrhage. The vessels at the base of the brain are normally situated and unremarkable. There is no evidence of herniation nor is there prominent notching of the cerebellar tonsils or unci. There is no midline shift. The brain is placed in formalin for further study. There are neither fractures nor natural disease of the skull.

CAVITIES: The thoracic and abdominal viscera are normally disposed. The diaphragm is intact. There is no free fluid in the pleural or peritoneal cavities. There are 3-4 ml of amber fluid in the pericardial sac. The body wall fat measures 1/4 inch in thickness.

NECK: The soft tissue of the neck contains a small hematoma of an estimated 0.5 ml volume on the left side. No natural disease is seen. There are no fractures of the hyoid bone or thyroid cartilage. There are no petechial hemorrhages within the larynx or pharynx.

CARDIOVASCULAR SYSTEM: The epicardium is smooth and glistening. The coronary arteries on the epicardial surface are normally disposed. The myocardium is dark brown and intact. The endocardium is smooth and glistening. The cardiac valves are intact. The coronary ostia are normally situated and are widely patent. There is a separate ostium within the right sinus of Valsalva for the conus branch. The foramen ovale and ductus arteriosus are closed. The aorta is normally formed and unremarkable.

RESPIRATORY SYSTEM: The larynx, trachea and bronchi are widely patent. The lungs are pink and contain a moderate amount of edema. No natural disease is seen. There are no focal lesions. There are no emboli within branches of the pulmonary artery.

LIVER: The capsule is smooth and glistening. The parenchyma is dark brown and intact. The gallbladder contains 2-3 ml of bile and no gallstones.

SPLEEN: The capsule is smooth and glistening. The parenchyma is dark red with prominent malpighian corpuscles and is unremarkable.

LYMPH NODES: Unremarkable where seen. They are prominent, particularly within the mesentery. Lymphoid follicles are seen within the duodenum.

GENITOURINARY SYSTEM: The capsules of the kidneys strip with ease revealing smooth cortical lobulated cortical surfaces. On sectioning there is good corticomedullary demarcation. The mucosa of the renal pelvis is smooth and white. The ureters are intact. The urinary bladder mucosa is white and smooth. The vagina is lined by intact tan epithelium. The cervix and uterus are normally formed and unremarkable. Each ovary contains several small cysts filled with clear fluid.

GASTROINTESTINAL TRACT: The esophagus and pharynx are lined by intact blue-gray mucosa. The stomach contains approximately 15 ml of curdled white soft material consistent with milk. Semiliquid white chyme is present within the duodenum. The mucosal surfaces of the stomach, duodenum, jejunum, ileum and colon are intact and unremarkable. The appendix is present. The serosal surfaces are smooth and glistening.

Ken Kooistra (KK): We'll start. Today's date is November 6th. The time is approximately 3:58 p.m. Present in the room are Detective Tim Williams, Detective Ken Kooistra and [REDACTED]. [REDACTED]. Detective Williams and myself have gone through these constitutional rights and you have signed the card indicating that you understand those rights and you're willing to talk to us in regards to an incident that took place on today's date over at [REDACTED]. Is that correct?

[REDACTED] (CF): Yes.

KK: Okay, why don't you, in order to get things together and understand the whole story, why don't you tell us a little bit about the background? I understand that you live with these people at this address?

CF: Yes, I do.

KK: Okay, what are their names?

CF: Um [REDACTED] and [REDACTED]

KK: Okay, and when did you move in with these people?

CF: About, in October, October 2nd.

KK: October 2nd of 1986?

CF: Yes.

KK: Okay.

Tim Williams (TW): Why is that?

KK: What was the arrangements that you had when you moved in?

CF: The arrangement was to babysit the kids while they were at work and to keep the house clean. That's all.

CF: Around one o'clock.

TW: Around one o'clock? What do you do, just put her in the tub?

CF: I set her in the tub.

TW: Okay.

CF: I usually just set her in there, ya know, and just go do what I had to do and go back in and get her out. But I had got her in, went outside to pick up [REDACTED] which it was only a few minutes before [REDACTED] had to get home. So he got home and I went back in to check on her. She was still playin'. And I went in the kitchen to fix their lunch and I went to feed them. She was still splashing water so I thought she'd still be playing. I should've just went in there and got her out but I didn't. I thought I'd just let her play cuz she usually throws a tantrum when she gets out of water.

TW: Okay, so how much longer did ya wait before ya went to check on her again?

CF: Oh, around um--ten after two.

TW: Okay, ten after two is when you checked on her again?

CF: Yea, cuz her brother got home around one thirty today.

TW: Okay, so when was the last time you checked her prior to ten after two?

CF: Um-m-m-I went in....

TW: In terms of minutes, ya know, was it twenty minutes or ten minutes or a half hour? Do ya understand what I'm sayin'?

CF: Well, when he got home at one thirty, I heard her splashing. That was around one thirty-five.

TW: Okay.

KK: Did you go in and check on her?

CF: Yes.

KK: Okay, and she was alright?

CF: Yes.

KK: Okay, and you made lunch and then what? Did you check on her from one thirty-five until two ten?

KK: How much--how much experience, [REDACTED], have you had in babysitting? I mean, do you do that quite a bit? Are ya--this is not the first time, obviously, that you babysat, right?

CF: I babysatted about three or four times with my little cousin, [REDACTED].

KK: Okay. Had you babysat before as a--as a young girl like when you were thirteen, fourteen, fifteen?

CF: No.

KK: Okay, and how about when you babysat, have you ever given other kids baths? Or is this the first time you've ever given---






View of similar carton - NOT carton of ring used
IN incident. 5/4/88




View of bottom of carton similar to one that contained


View of actual ring used in incident




View of top of carton similar to one containing ring involved 5/4/88
