

PRE-EVENT

This fatality involves an air rifle. Information in this report was obtained from the victim's father and local officials. I requested information from the family that owned the gun but they have not responded to my letter or telephone calls, see exhibit # 4. Any additional information received from them will be forwarded for inclusion with this report upon receipt.

The victim lived at home with his 12 year old brother and parents in Phoenix, Arizona. Local officials described the victim (P) as a 10 year old boy who was in the fourth grade. The Medical Examiner listed the victim's weight at 55 pounds and his height as 55 1/2 inches.

This incident took place during Thursday, April 4, 1996. The victim's father told me that his sons were at home because it was spring break.

The father told Police Officer BG that he left for work around 5:30 a.m. His wife left for work around 5:40 a.m. Their two boys (P & M) were still asleep when they left the house.

Both witnesses of this incident (brother M and friend F) were interviewed separately by Phoenix Police Detective S. Other officers spoke with these two witnesses.

The victim's father said that they did not have any guns or rifles of any type at their home. He would not allow them to own or use pellet/BB guns.

Brother M told Detective S that he got up that morning around 9 a.m. His parents had already left for work and his brother, the victim, was already up by that time.

Brother M said that he walked over to friend F's house around 11 a.m. Friend F was 12 years old and in the sixth grade.

About 20 minutes later his brother arrived. They played video games for about one hour.

The victim, his brother and friend F all went over to the victim's house around 12 noon. They decided to take two pellet air rifles and one BB pistol with them.

Friend F told Detective S that all three guns belonged his older brother who was 15 years old. His brother did not know that they took the guns.

The boys placed the three guns in a blue bathrobe and took them to the victim's house, see photo # 1.

Detective S told me that one of the air rifles can either be operated as an air pump type gun or you can use a CO2 cartridge. He said the victim was shot by this gun. Detectives were told by friend F that they did not have a CO2 cartridge in this rifle at the time of this incident.

The second air rifle had red paint on the barrel. This rifle was operated by a pump lever. It could not be operated with a CO2 cartridge.

Detective C described the victim's home as a single story residential structure located on the north side of the street. The front door faces south and is located just east of the carport area which encompasses the west end of the residence.

The living room area is located north of the front door, see photos 8 & 9. This is where the injury occurred.

All three boys shot the guns in the back yard of the victim's house. They fired the guns at "POGS" which were taped to the back fence and at birds.

After a while the boys went inside the house. Friend F said that they scrambled some eggs and watched television for a while.

At one point the victim went into the living room and decided to call his father at work. He was going to ask for permission to go over to the house of another friend.

Detective C reported that the living room has a three cushion tan colored sofa up against the east wall. A wall unit containing a television and stereo components is located against the west wall of the living room. A fire place, two table and a chair are near the north wall of the living room, see photos # 8 & 9.

While the victim was on the telephone his brother, M, picked up the pellet rifle which includes the CO2 feature. Brother M stated to Officer KS that he shook the gun and did not hear any ammunition inside.

He told Detective S that he pulled the lever back where you load the pellets and looked inside. He did not see a pellet and decided that the gun was unloaded. Brother M then gave the gun to friend F.

Friend F took the gun and said "Okay, I'm gonna scare your brother, watch." Friend F told Detective S that he thought the gun was out of ammunition and that it only had air in it.

Detective S said that the boys do not remember if the gun was pumped just before the fatal shot was fired or if it had been pumped earlier. In addition, they do not remember exactly how many times the gun was pumped. One estimate was that it may have been pumped as many as ten times.

Friend F took the gun, raised it to his shoulder and pointed it at the victim. He told Detective S that the barrel of the gun was about two or three feet away from the victim's head.

The victim was still on the telephone. He was sitting on the floor while brother M and friend F were seated on the sofa behind and to his right, see photo # 8. The victim turned his head just as friend F pulled the trigger on the air rifle.

EVENT

The air rifle discharged a pellet. This pellet entered the victim's head through his right ear.

POST-EVENT

Brother M told police that his brother fell. He then crawled from the living room into the family room. He collapsed in front of a second television which was located in the family room. He was unconscious. Blood was coming from the side of his head. Brother M grabbed the telephone and yelled at the lady on the other end to get his dad.

The father told me that while at work he received a telephone call from his son. The father answered the telephone and found his son M on the line. His son was hysterical. M told him that his other son, P, had fallen and hit his head. The father was later told by M that P was shot with a BB gun by their friend, F.

The father told his son M to call 9-1-1. The boy called and requested medical assistance. Paramedics and police were sent to the scene at about 1:45 p.m.

Brother M was very concerned about the presence of the guns in the house because their parents did not allow them to have access to guns. He had friend F grab the guns and remove them. F took the two air rifles and the BB pistol and wrapped them up in a blue bathrobe, see photo # 1. He then took them to his home.

Officer KS responded to the scene and found paramedics treating the victim in the family room where the two cushion sofa was located, see photos # 9 & 10.

Officer KS interviewed the victim's brother and their friend. At that time the two boys gave a false story. They suggested that the victim and his brother were wrestling when he threw him onto the couch. Paramedics indicated that this story did not fit the facts.

Detective C reported that there was a blood trail leading from the living room into the family room. A two cushion tan colored sofa facing south is located in the family room. They found a bloody white pillow on top of the two cushion sofa, see photo # 11.

Other officers arrived at the scene and the boys finally came forward with the facts. F told the officers that he shot the victim with an air rifle.

The victim was air lifted to St. Joseph's Hospital, Phoenix, Arizona. Officer BG was directed to the hospital where he spoke with the medical staff. The victim was still being treated in the emergency room at this time.

Dr. H pronounced the victim dead at 3:35 p.m. Dr. H told Officer BG that he believed the pellet entered from an angle just slightly behind the victim's right ear. This pellet traveled through the brain and stopped in the left temporal area.

A Medical Examiner with Maricopa County conducted an autopsy which Detective S attended. Detective S observed an entrance wound in the victim's right ear just above the opening to the auditory canal. He reported that x-rays showed a projectile in the left portion of the brain.

The Medical Examiner determined that the cause of death was a gunshot (pellet) wound to the head. Her pathologic diagnoses included:

- I. Penetrating gunshot wound of head.
 - A. Distant entrance wound of right external ear.
 - B. Track through right external ear skin and cartilage, right temporalis muscle, right temporal lobe, lodging in the left frontal lobe of brain.
 - C. Nondeformed, grey, small metal pellet recovered from the left anterior frontal lobe of brain.
 - D. Path of gunshot would: Right to left, slightly upward, slightly back to front.

A copy of the Medical Examiner's investigation and autopsy reports are attached as exhibit # 5.

Police officials collected the guns from the friend's home. Both Detective S and Detective M examined the two air rifles.

Detective S identified the gun involved in this death as the air rifle which could be operated as a pump air rifle or with a CO2 cartridge. He said that he examined this rifle and found it was impossible to tell if the gun was loaded. He loaded the gun with a pellet, pulled the bolt back and looked into the breach of the barrel. He could not see the pellet.

Detective M reported that he examined both rifles and loaded them. He then looked in the breech after the bolt had been put in battery then retracted. He said that the projectile was not viable. Once placed in battery, he found that the projectile could only be removed by firing the gun or by striking the butt on a hard surface several times or once with increased force, see exhibit # 7.

A copy of the Phoenix Police Original Report and Supplemental Reports are attached as exhibits # 6 & 7. While at the police station I examined their scene photographs. Copies of police photos showing the living room, the family room, the air rifles and the pistol are attached as exhibit # 8.

I've requested access to the air rifle involved in this incident. Detective S stated that it is currently at their laboratory for testing. He indicated that I could probably examine it after their testing is completed. I also requested a copy of their laboratory report. This information will be forwarded for inclusion with this report upon receipt.

During 4-25-96 I was informed by a private investigator, Mr. AH, that he has been hired by the victim's family attorney to investigate this death.

PRODUCT IDENTIFICATION

Police identified the air rifle involved in this fatality as a model # 990 from Daisy. The reference book Brands and Their Companies has a listing for Daisy as follows:

This air rifle uses .177 caliber ammunition. Pellets can be fired from this air rifle using an air pump mode or a CO2 cartridge mode. Police photographs of this air rifle are attached, see photos # 2 - 5.

A second air rifle found at the scene was identified by Phoenix Police as a Daisy model 880, see photos # 6 & 7.

I made several unsuccessful attempts to speak with the family who owned the air rifle involved in this fatality. Therefore, I was unable to 1) obtain any information about their past experience with the gun, 2) find out where the gun was purchased 3) nor was I able to examine the owner's manual.

I contacted six local stores in an attempt to locate the same brand/model air rifle involved in this incident. Most of the stores carried air rifles but none had this particular model.

No other product information was available.

CIRCUMSTANCES OF DEATH

This is a 10-year-old Caucasian male reportedly shot in the ear by a pellet rifle. The rest of the circumstances of the shooting are under investigation.

An autopsy is performed at the Maricopa County Office of the Medical Examiner, Phoenix, Arizona on the 3rd day of April, 1996.

CLOTHING

The body bag is sealed with seal #739425. The body is received unclad.

EXTERNAL EXAMINATION

The body is that of a well developed, well nourished Caucasian male child who weighs 55 pounds, is 53-1/2 inches in height and appears compatible with the stated age of 10 years. The unembalmed body is cool to touch. Rigor mortis is fully fixed in all extremities and the jaw. Fixed purple livor mortis extends over the posterior surfaces of the body, except in areas exposed to pressure. The scalp hair is blonde and measures to 2-1/2 inches in length over the crown. The eyes have been donated. The nose and ears are not unusual. The natural teeth are in good repair. The neck is unremarkable. The thorax is well developed and symmetrical. The abdomen is flat. The anus and back are unremarkable. The genitalia are those of a normal male child. The penis is circumcised. The testes are bilaterally descended within the scrotum. The upper and lower extremities bilaterally are well developed and symmetrical, without absence of digits. Identifying marks and scars include scattered freckles over the nose and cheeks ranging 1/16 to 1/8 inch in greatest dimension. There is a 1 inch white scar on the posterior right forearm. There is a white scar of the right lateral knee, 1/4 by 1/8 inch.

MEDICAL INTERVENTION

Evidence of medical intervention includes an endotracheal tube present in the mouth. There is an orogastric tube present within the mouth. There is a temperature monitor located on the forehead. There is an IV line present in the right lateral neck. There are two puncture marks in the right antecubital fossae. There is an arterial line in the right radial artery. There is a Foley catheter in place in the urethra. There is an IV present in the left antecubital fossa. There is an IV present in the left posterior hand. The patient has been a full organ donor and has a 16 inch fresh sutured donor incision down the midline of the trunk.

EVIDENCE OF INJURY**HEAD AND NECK:**

There is a single entrance gunshot wound to the right external ear. The entry wound has a graze wound posterior to the entry

itself. The graze is a red abrasion 1/2 by 1/8 inch. The entry wound is 1/16 by 1/16 inch. It shows no soot, no tattooing, no abrasion ring. The entrance wound is located 5-7/16 inches right of the anterior midline, 4-1/2 inches from the top of the head, 48-1/2 inches from the heels and 25 inches from the gluteal fold. There is a green-blue contusion located just anterior to the right ear in the right temple area that is 2 by 2 inches.

The projectile has caused massive hemorrhage within the right temporalis muscle. There is a single bony entrance wound to the right temporal bone that is 1/4 by 3/16 inches. There are no other fractures to the skull. The projectile enters the right temporal lobe of the brain, crosses the midline, and is recovered from the left frontal lobe of the brain. It is a distant gunshot wound. The projectile is recovered at 10:55 from the left anterior frontal lobe of the brain. It is a nondeformed, small grey metal pellet.

In addition to the gunshot wound to the head there is a tan contusion of the right mid neck, 1-1/2 by 3/4 inches.

THORAX AND ABDOMEN:

No evidence of injury.

UPPER EXTREMITIES:

There is a tan contusion of the left lateral upper arm, 1/4 by 1/4 inch. There is a triangular blue contusion on the left anterior upper arm, 3/4 by 3/4 inches. There is a tan contusion on the left lateral forearm 1/2 by 1/2 inch.

LOWER EXTREMITIES:

There is a purple contusion of the right medial calf, 1 by 1 inch. There is a pale purple contusion of the left medial ankle, 7/16 by 3/8 inch. There is a 1/2 by 1/4 inch blue contusion of the left lateral ankle. There is a dark green contusion of the lower lateral left shin, 1/8 by 3/16 inch. There is a dark green contusion of the left lower lateral shin 3/8 by 1/8 inch. There is a mid left shin tan contusion, 1 by 7/8 inch. There is a left medial calf tan contusion, 5/8 by 3/8 inch. There is a left medial upper chin purple contusion, 1/2 by 1/2 inch. There is a purple contusion of the lower left medial knee, 1/8 by 3/8 inch. There is a medial left knee purple contusion, 3/4 by 3/4 inch.

INTERNAL EXAMINATION**BODY CAVITIES**

The donor incision is enlarged by adding a Y-shaped chest incision. The internal trunk organs are missing except for a fragment of spleen, a fragment of adrenal gland and an intact stomach. No gross abnormalities are noted to any of these

BODY CAVITIES (Continuation)

organs. The stomach contains 140 ml. of thick green semisolid material. The neck organs have been left intact. The subcutaneous fat layers of the abdominal wall is 1 cm. thick.

HEAD (CENTRAL NERVOUS SYSTEM)

The head is opened in the usual manner revealing subscapular hemorrhage in the area of the gunshot wound and massive right temporalis muscle hemorrhage. The skull is opened revealing a right subdural hematoma and a generalized subarachnoid hemorrhage. The brain weighs 1420 grams. The dura mater and falx cerebri are not intact. The leptomeninges are thin and delicate. The cerebral hemispheres are edematous but symmetrical. The structures at the base of the brain, including cranial nerves and blood vessels, are intact and free of abnormality. Sections through the cerebral hemispheres reveal maceration and hemorrhage in the path of the projectile. There is a bilateral intraventricular hemorrhage. Sections through the brain stem and cerebellum are unremarkable. The spinal cord is not examined.

NECK

Examination of the soft tissues of the neck, including strap muscles and large vessels, reveals no abnormalities. The hyoid bone and larynx are intact. The tongue is normal.

EVIDENCE

The following items are collected and preserved:

- the previously described projectile is collected from the left anterior frontal lobe of the brain at 10:55

TOXICOLOGY

A subdural clot is collected at autopsy. Blood and vitreous fluid are collected by the Arizona Donor Network at the time of organ donation.

HISTOLOGY

Representative sections are taken for storage and microscopic examination.

MICROSCOPIC DESCRIPTION

Brain: Sections of non-traumatized brain show subarachnoid hemorrhage and are otherwise unremarkable.

PHOTOGRAPHS

An identification photograph is taken. Extensive photographs are taken by the Phoenix Police Department.

X-RAYS

X-rays are taken revealing a single projectile in the left portion of the head.

OPINION

In my opinion, Peter Jonathan Braun died as a result of a single gunshot wound to the head.

AT 1348 HOURS I RESPONDED TO EMERGENCY TRAFFIC OF AN INJURED PERSON AT 1416 WEST RENEE. ON ARRIVAL AT 1356 HOURS I FOUND THAT OFFICERS ESPERUM (T420) AND SHRINER (932P) WERE ALREADY AT THE SCENE, AS WAS LADDER 41 AND

EP41, C-SHIFT. AS I ENTERED THE RESIDENCE ON RENEE, THE FIRE DEPARTMENT WAS STARTING TO TREAT THE VICTIM, PETER, WHO WAS UNCONSCIOUS AND HAD A PUNCTURE WOUND ON THE UPPER RIGHT SIDE OF HIS HEAD, BEHIND THE EAR. THE SCENE WAS EXTREMELY CHAOTIC AS FIRE FIGHTERS WERE ATTEMPTING TO FIND OUT WHAT HAD HAPPENED TO THE BOY SO PROPER TREATMENT COULD BE PROVIDED.

THE VICTIM'S BROTHER, W1 MICHAEL BRAUN, STATED THAT HE WAS WRESTLING WITH HIS BROTHER AND KNOCKED HIM ONTO THE COUCH. HE STATED THAT THEN THE BOY WALKED INTO THE ADJOINING ROOM JUST SOUTH WHERE HE COLLAPSED ON THE FLOOR AND WAS NOW BEING TREATED BY PARAMEDICS. WE ADVISED THE WITNESS BRAUN THAT HE HAD BEEN HIT WITH SOMETHING IN THE HEAD, BUT THE WITNESS INSISTED THAT HE HAD NOT.

I THEN SPOKE WITH WHAT TURNED OUT LATER TO BE THE SUSPECT, MICHAEL FLEMM. I ASKED HIM WHAT HAD HAPPENED AND MICHAEL TOLD ME HE HAD NO IDEA, THAT HE WAS WATCHING TELEVISION AND DIDN'T SEE ANYTHING. THE WITNESS AND THE SUSPECT WERE THEN SEPARATED AND I TOOK MICHAEL FLEMM INTO THE FIRST BEDROOM DOWN THE HALL ON THE RIGHT. I SAT MICHAEL DOWN AND STARTED TO TALK TO HIM. HE REMEMBERED THAT IT WAS ME HE HAD CONTACT WITH IN THE PAST WHEN HE WAS THE SUSPECT IN AN EXTORTION SITUATION. I KNEW THAT THE BOY WAS DEVISS AND CON-WISE BEYOND HIS YEARS, BUT I EXPLAINED TO HIM I COULD NOT UNDERSTAND HOW HE COULD SIT IN THE SAME ROOM WHERE THIS ALLEGED WRESTLING MATCH HAD GONE ON AND DIDN'T SEE ANYTHING. I THEN TOLD FLEMM THAT I HAD TO KNOW WHAT HAD OCCURRED AND THAT THE PARAMEDICS NEEDED TO KNOW HOW TO TREAT THE VICTIM BEFORE THE SITUATION GOT WORSE. AFTER SOME MORE SMALL TALK, FLEMM FINALLY TOLD ME THAT HE WOULD TELL THE TRUTH IF WITNESS BRAUN WAS IN THE ROOM.

AT THIS TIME WITNESS BRAUN WAS BEING INTERROGATED BY OFFICER SHRINER IN THE DINING ROOM AREA OFF OF THE KITCHEN. I ASKED OFFICER SHRINER TO BRING BRAUN INTO THE BEDROOM. ONCE IN THE BEDROOM, BOTH BOYS SAT ON THE BED WITH OFFICER SHRINER STANDING AND MYSELF STANDING IN THE DOORWAY. AT THIS POINT FLEMM SAID TO BRAUN, "GO AHEAD, LET'S TELL THEM THE TRUTH." FLEMM THEN TURNED TOWARDS OFFICER SHRINER AND I AND SAID, "I SHOT HIM."

AT THAT POINT P1 CHRISTOPHER BRAUN GOT A LITTLE CRAZY IN THE HALLWAY AS HE HEARD WHAT FLEMM HAD SAID. I REMOVED MR. BRAUN TO ANOTHER PART OF THE HOUSE UNTIL HE SETTLED DOWN. THIS WAS DONE FOR THE SAFETY OF THE SUSPECT.

AS FLEMM AT THIS POINT, BY HIS STATEMENT, WAS NO LONGER A WITNESS AND BECAME A SUSPECT, INTERROGATION OF HIM WAS TERMINATED AT THAT POINT AND DEFERRED UNTIL DETECTIVES ARRIVED AT THE SCENE.

ARMED WITH THIS INFORMATION, I CALLED FOR A SUPERVISOR TO COME TO THE SCENE AND CALLED ASSAULTS DETAIL WHO ALSO RESPONDED. THE VICTIM WAS TREATED BY PARAMEDICS AND AIR-EVACED TO BARROWS NEUROLOGICAL CENTER AT ST. JOSEPH'S HOSPITAL BY DPS RANGER 41.

I THEN SPOKE FOR A SHORT PERIOD OF TIME WITH W1 MICHAEL BRAUN. BRAUN TOLD ME THAT THE BOYS HAD BEEN SHOOTING THREE BB GUNS THAT FLEMM HAD BROUGHT OVER TO THE HOUSE IN THE BACKYARD. THE BOYS THEN CAME INTO THE HOUSE AND

STARTED WATCHING TELEVISION AND HIS BROTHER, THE VICTIM, PETER, WAS IN THE PROCESS OF CALLING HIS FATHER, P1 CHRISTOPHER, ON THE TELEPHONE WHEN HE WAS SHOT BY SUSPECT FLEMM. MICHAEL TOLD ME THAT HE CHECKED THE GUN LESS THAN A MINUTE BEFORE THE SHOOTING BY PULLING BACK THE BOLT AND CHECKING TO INSURE THAT THERE WAS NO BB OR PELLET IN THE CHAMBER. THE SUSPECT FLEMM THEN INSISTED ON GETTING THE GUN BACK. W1 BRAUN DOES NOT REMEMBER SEEING FLEMM LOAD A .177 CALIBER PELLET INTO THE WEAPON, BUT HE DID SEE FLEMM RAISE THE WEAPON UP TO THE VICTIM'S HEAD AND FROM ONLY A FEW INCHES AWAY, FIRE THE LETHAL SHOT.

THE WITNESS MICHAEL BRAUN DID NOT THINK HIS BROTHER WAS SERIOUSLY INJURED AND HE KNEW THAT THEY WOULD ALL GET IN TROUBLE IF IT WAS FOUND OUT THAT THEY WERE SHOOTING THESE GUNS; THAT WAS THE REASON FOR THE ORIGINAL LIE AND COVER UP. W1 BRAUN WAS UNAWARE OF HOW SERIOUSLY HIS BROTHER WAS INJURED.

I WAS THEN DESIGNATED BY SERGEANT RICE, WHO RESPONDED TO THE SCENE, TO MAINTAIN A LOG OF WHO ENTERED THE RESIDENCE. I MAINTAINED THAT LOG UNTIL WE SECURED FROM THE SCENE AT 1850 HOURS WHEN THAT LOG WAS TURNED OVER TO DETECTIVE COONING #3338 (C340).

IT SHOULD BE NOTED THAT DURING THE INITIAL ENTRIES INTO THE LOG, THE ARRIVAL TIMES OF THE FIRST UNITS WERE ESTIMATED UNTIL I ARRIVED AT 1356 HOURS. THE ACTUAL ARRIVAL TIME FOR OFFICER ESPERUM (T420) SHOULD BE 1349 HOURS. THE ORIGINAL ARRIVAL TIME FOR OFFICER SHRINER (932P) SHOULD BE 1352 HOURS. THE FIRST FIRE UNIT, LADDER 41, ALSO ARRIVED AT 1352 HOURS.

WHILE THE SCENE WAS VERY CHAOTIC WITH THE COMING AND GOING OF PARAMEDICS, FIRE RESCUE UNITS AND HELICOPTER RANGER 41, ALONG WITH OFFICERS AND SUPERVISORS, A SHORT CONVERSATION WAS HAD WITH A NEIGHBOR, W2 DEBBIE J. LEDUNE. MS. LEDUNE TOLD ME THAT SHE HAD HEARD AN ARGUMENT COMING FROM THE HOUSE AT 1416 WEST RENEE SHORTLY PRIOR TO ALL THE COMMOTION. MS. LEDUNE SAID THE BOYS WERE ARGUING BECAUSE ONE WOULD NOT LET ANOTHER ONE INTO SOME ROOM IN THE HOUSE. JUST A COUPLE OF MINUTES AFTER THAT SHE OBSERVED THE SUSPECT FLEMM, WHO SHE KNOWS BY SIGHT, LEAVING THE HOUSE CARRYING SOMETHING WRAPPED IN A BLANKET. SHE SAID THAT FLEMM RAN DOWN TO HIS HOUSE ON THE CORNER WITH THIS ITEM AND THEN RETURNED TO THE BRAUN RESIDENCE. IT WAS LATER DETERMINED BY TALKING TO W1 MICHAEL BRAUN THAT THESE WERE THE GUNS THAT FLEMM HAD BROUGHT TO THE HOUSE EARLIER. THIS INFORMATION WAS PROVIDED TO RESPONDING DETECTIVES WHO TOOK THE APPROPRIATE STEPS IN FOLLOW UP INVESTIGATION AND INTERVIEW OF THIS WITNESS.

THEN CAME IN THE HOUSE SO PETER COULD USE THE PHONE AND FLEMM SHOT HIM IN THE HEAD, APPARENTLY BELIEVING THE GUN WAS UNLOADED. SGT. MILLWARD REQUESTED I INTERVIEW MIKE BRAUN, WHO WAS INSIDE THE HOUSE WITH OFFICER RYAN.

I CONTACTED MIKE WHO WAS SEATED AT THE KITCHEN TABLE AND ASKED HIM TO TELL ME WHAT HAPPENED. MIKE EXPLAINED THAT ABOUT AN HOUR BEFORE THE SHOOTING, MIKE FLEMM CAME OVER WITH 2 PELLET RIFLES AND A BB PISTOL. THE THREE OF THEM SHOT AT THE BACK FENCE FOR A WHILE THEN CAME INSIDE. PETER WAS GOING TO CALL HIS FATHER TO GET PERMISSION TO GO TO A FRIENDS HOUSE. AT THAT TIME PETER WAS SITTING ON THE FLOOR OF THE ROOM DIRECTLY EAST OF THE KITCHEN. MIKE FLEMM AND MIKE BRAUN WERE SEATED ON THE SOFA BEHIND AND TO PETER'S RIGHT. MIKE SAID HE LOOKED IN THE CHAMBER OF ONE OF THE RIFLES AND THOUGHT IT WAS EMPTY. MIKE FLEMM THEN TOOK THE RIFLE, POINTED IT AT PETER'S HEAD AND PULLED THE TRIGGER. THE GUN DISCHARGED STRIKING PETER IN THE RIGHT SIDE OF THE HEAD.

ON 4-3-96 AT APPROXIMATELY 12:20 A.M. I RESPONDED TO ST. JOSEPH'S HOSPITAL AT 350 W. THOMAS ROAD TO COMPLETE THE BODY TAG ON PETER BRAUN WHOSE DEATH HAD BEEN INVESTIGATED EARLIER THE PREVIOUS DAY BY THE ASSAULT AND HOMICIDE DETAIL. I HAD BEEN GIVEN THE BODY TAG EARLIER IN THE EVENING AND HAD BEEN INFORMED THAT THE MEDICAL EXAMINER HAD GIVEN PERMISSION FOR PETER BRAUN TO BE AN ORGAN DONOR.

THE BODY WAS LOCATED IN THE HOSPITAL MORGUE IN A WHITE PLASTIC BODY BAG. AFTER CHECKING WITH THE ORGAN DONOR PERSONNEL IT WAS LEARNED THAT NO MORTUARY HAD BEEN REQUESTED BY THE FAMILY. THE MEDICAL EXAMINER'S OFFICE WAS CONTACTED AND THE NEXT ROTATION MORTUARY PHOENIX MEMORIAL WAS CALLED TO TRANSPORT THE BODY. I DID SEAL THE BODY BAG WITH TAG #739425.

ON 4-2-96 AT ABOUT 1435 HRS, SGT. MILLWARD TOLD ME TO ASSIST IN THIS INVESTIGATION. HE HAD JUST LEARNED THAT A 10 YEAR OLD BOY HAD BEEN SHOT IN THE HEAD WITH A BB TYPE GUN AND THE BOY WAS BEING TRANSPORTED TO ST. JOSEPH'S HOSPITAL. I ARRIVED AT THE HOSPITAL ABOUT 1515 HRS AND SAW THE VICTIM PETER BRAUN BEING TREATED IN THE EMERGENCY ROOM. I SAW AN XRAY OF PETER'S HEAD INDICATING HE HAD A PELLET IN HIS HEAD. THE STAFF ADVISED ME THAT THEY WERE GOING TO TAKE PETER TO GET A CAT SCAN TO DETERMINE A BETTER LOCATION OF THE PELLET.

I THEN CONTACTED THE FLIGHT CREW WHO HAD TRANSPORTED PETER BRAUN (VAUGHN PERKINS, BUD CLARK, AND CARLOS PISANO). THEY TOLD ME THAT PETER HAD BEEN UNRESPONSIVE DURING THEIR CONTACT WITH HIM. THEY DID NOT NOTE ANY OTHER INJURIES TO PETER OTHER THAN THE INJURY TO HIS RIGHT EAR.

AFTER TALKING TO THE FLIGHT CREW I BRIEFLY SPOKE TO OFF. ENG #3667. ENG TOLD ME THAT HE HAD TRANSPORTED THE VICTIM'S PARENTS TO THE HOSPITAL AND HE HAD NO OTHER INVOLVEMENT IN THE INVESTIGATION.

NEXT I NOTIFIED SGT. MILLWARD BY PHONE THAT THE VICTIM'S CONDITION WAS VERY SERIOUS. I THEN WENT UP TO THE PEDIATRIC ICU AND SAW THAT HOSPITAL STAFF WERE WORKING ON THE VICTIM. I SPOKE TO DR. JEFF HILL WHO WAS ATTENDING TO THE VICTIM. HE PRONOUNCED THE VICTIM'S DEATH AT 1535 HRS IN THE PEDIATRIC ICU. DR. HILL LATER SHOWED ME AN ABRASION ON THE VICTIM'S RIGHT EAR WHICH HE BELIEVED WAS THE PELLET ENTRANCE. DR. HILL TOLD ME THAT HE BELIEVED THE PELLET ENTERED FROM AN ANGLE JUST SLIGHTLY BEHIND THE RIGHT EAR. THE PELLET TRAVELED THROUGH THE BRAIN AND STOPPED IN THE LEFT TEMPORAL AREA.

HOSPITAL STAFF NOTIFIED KARYLE AND CHRISTOPHER BRAUN (VICTIM'S PARENTS) OF THEIR SON'S DEATH AT THE HOSPITAL. I REMAINED AT THE HOSPITAL UNTIL ABOUT 1825 HRS. DURING THAT AFTERNOON I SPOKE TO BOTH PARENTS BRIEFLY.

CHRISTOPHER BRAUN TOLD ME THAT HIS SON PETER WAS ON SPRING BREAK THIS WEEK AND THAT PETER IS IN THE 4TH GRADE AT DESERT WINDS SCHOOL. CHRISTOPHER SAID HE LEFT HOME THIS MORNING FOR WORK AROUND 0530 HRS AND BELIEVES HIS WIFE KARYLE LEFT FOR WORK AT ABOUT 0540 HRS. BOTH OF THEIR SONS (PETER AND MICHAEL) WERE SLEEPING WHEN CHRISTOPHER LEFT. CHRISTOPHER TOLD ME THAT THEY DO NOT HAVE ANY GUNS OR RIFLES OF ANY TYPE AT THEIR HOUSE.

CHRISTOPHER TOLD ME THAT HE FIRST LEARNED OF THE INCIDENT WHEN HIS SECRETARY ROSE FABIOUN TOLD HIM THAT HIS SON PHONED FOR HIM AT WORK. CHRISTOPHER SAID THAT AS SOON AS HE GOT ON THE PHONE WITH HIS SON MICHAEL THAT MICHAEL WAS HYSTERICAL. MICHAEL TOLD HIM THAT PETER HAD FALLEN AND

HIT HIS HEAD. MICHAEL LATER TOLD HIM THAT PETER WAS SHOT WITH A BB GUN BY THEIR FRIEND MICHAEL FLEMM. MICHAEL TOLD CHRISTOPHER THAT HE HAD LOOKED INTO THE BB GUN AND SAW THAT IT WAS EMPTY. CHRISTOPHER TOLD HIS SON MICHAEL TO CALL 911 AS SOON AS HE HUNG UP. CHRISTOPHER ALSO PHONED 911 FROM HIS WORK AND THEN HE WENT HOME. CHRISTOPHER ALSO SAID THAT HE BELIEVED THAT JUST BEFORE THE SHOOTING THAT HIS SON MICHAEL HAD BEEN TALKING TO ROSE. MICHAEL HAD CALLED TO ASK HIM IF THEY COULD LEAVE THE HOUSE.

I ALSO BRIEFLY SPOKE TO KARYLE BRAUN. SHE TOLD ME THAT SHE HAD BEEN AT WORK AND GOT A PHONE CALL FROM HER HUSBAND'S SECRETARY TELLING HER THAT SOMETHING WAS WRONG AT HOME. SHE PHONED HOME AND SPOKE TO HER SON MICHAEL. MICHAEL TOLD HER THAT THEY WERE WRESTLING AND THAT BLOOD WAS COMING OUT OF PETER'S EAR. KARYLE THEN BRIEFLY SPOKE TO A PARAMEDIC WHO TOLD HER THAT THEY WERE GOING TO TRANSPORT PETER TO THE HOSPITAL BY HELICOPTER.

AT ABOUT 1815 HRS OFFICERS ARRIVED WITH MICHAEL BRAUN AT ST. JOSEPH'S HOSPITAL. I ESCORTED HIM TO HIS PARENTS AND THEN LEFT THE HOSPITAL. THEN I RETURNED TO THE MAIN POLICE STATION AND IMPOUNDED THE VICTIM'S CLOTHING THAT HAD BEEN GIVEN TO ME BY HOSPITAL PERSONNEL.

I ALSO STARTED A MEDICAL EXAMINER'S TAG FOR PETER BRAUN AND LEFT IT WITH DET. CHANEY AT THE G.I.B. DESK TO BE COMPLETED LATER WHEN THE HOSPITAL NOTIFIED THE DESK THAT THE VICTIM WAS READY FOR TRANSPORT TO THE M.E.

ON 4-5-96 ASSAULT DET. GIESEMAN CALLED AND AND STATED THAT VICTIM PETER BRAUN'S FATHER CHRIS, HAD JUST CALLED HIM FOR INFORMATION ON THIS INVESTIGATION. I THEN CALLED MR. BRAUN AND SPOKE WITH HIM ABOUT THE PROGRESS OF MY INVESTIGATION. I TOLD HIM THAT UP TO THIS POINT IN TIME, IT APPEARS THAT THE STORY HIS SON MIKE AND THE ONE MIKE FLEMM GAVE TO ME ARE BASICALLY THE SAME. I ALSO EXPLAINED TO HIM THAT I HAD PEERSONALLY LOOKED AT THE PELLET RIFLE AND FOUND IT WAS IMPOSSIBLE TO TELL IF IT WAS LOADED, BY JUST PULLING THE BOLT BACK AND LOOKING INTO THE BREACH OF THE BARREL. I TOLD MR. BRAUN THAT THE REPORT WOULD BE COMPELTED AND FORWARDED TO THE COUNTY ATTORNEY'S OFFICE FOR REVIEW. THEY WOULD THEN DECIDE IF ANY CHARGES WOULD BE BROUGHT AGAINST MIKE FLEMM.

AT THIS POINT I ASKED MR. BRAUN ABOUT THE BEER BOTTLES WE FOUND IN HIS TRASH AND THE BEER BOTTLE CAPS ON THE FLOOR OF HIS FAMILY ROOM. HE TOLD ME THAT BEER WAS CONSUMED THE NIGHT BEFORE BY HE AND HIS WIFE AND THE CAPS WERE PROBABLY LEFT ON THE FLOOR.

I RESPONDED TO AN INJURED PERSON CALL. THE FIRE DEPARTMENT WAS ON THE SCENE WHEN I ARRIVED. OFFICER ESPERUM #2829 HAD BEEN AT THE SCENE AND RETURNED JUST AS I ARRIVED. ESPERUM ADVISED ME THAT FIRE PERSONNEL POINTED OUT FLEMM TO HIM AS HE ARRIVED. FLEMM WAS RIDING HIS BICYCLE EASTBOUND ON RENEE, AWAY FROM THE SCENE. OFFICER ESPERUM STOPPED HIM AND HAD HIM RETURNED TO THE SCENE.

I CONTACTED MIKE BRAUN WHO ADVISED ME THAT HE HAD BEEN WRESTLING WITH HIS BROTHER PETER. MIKE SAID HE PICKED HIS BROTHER UP AND THREW HIM ONTO THE COUCH, IN THE LIVING ROOM. HE MUST HAVE HIT HIM WITH AN ELBOW OR A KNEE BECAUSE HE BEGAN BLEEDING AND CRAWLED INTO THE DEN. THE PARAMEDICS INTERRUPTED ME AT THIS TIME, SAYING THAT THE INJURIES DID NOT MATCH THE STORY.

A FEW MINUTES LATER OFFICER RYAN CAME TO GET ME AND MIKE. WE WALKED INTO THE BEDROOM AND OFFICER RYAN SAID, "OKAY, HERE HE IS." THE TWO BOYS EXCHANGED HEAD NODS AND BRAUN SAID "HE SHOT HIM WITH A BB GUN." BRAUN SAID THEY HAD BEEN SHOOTING THE BB GUN IN THE BACKYARD EARLIER. HE SHOOK THE GUN AND DIDN'T HEAR ANY BB'S. HE PUMPED IT UP AND HANDED IT TO FLEMM. FLEMM SHOT PETER FROM A DISTANCE OF TWO AND A HALF TO THREE FEET AS INDICATED BY BRAUN, HOLDING HIS HANDS APART.

FLEMM WAS IN AGREEMENT WITH THIS STORY AND SAID HE TOOK THE BB GUN HOME. HE AGREED TO TAKE ME TO HIS HOUSE AND SHOW ME WHERE THE BB GUN WAS.

PETER BRAUN WAS TRANSPORTED TO ST. JOSEPH'S HOSPITAL BY HELICOPTER. GIB ASSAULTS WAS CALLED. I CONTACTED DAVID FLEMM AND MET HIM AT HIS HOME. I HAD MIKE FLEMM IN THE BACK SEAT OF MY PATROL CAR FROM THE TIME THE HELICOPTER LEFT UNTIL I WAS CONTACTED BY DETECTIVES.

ON 4-2-96 I INTERVIEWED MICHAEL BRAUN WHILE IN HIS BROTHER'S BEDROOM AT 1416 WEST RENEE DRIVE. I BEGAN THIS INTERVIEW BY INTRODUCING MYSELF TO MIKE AND OBTAINING PERSONAL INFORMATION FROM HIM. MIKE TOLD ME HE LIVED AT THIS RESIDENCE WITH HIS MOTHER, FATHER AND BROTHER PETER. HE SAID HE IS IN THE SIXTH GRADE AT DESERT WINDS ELEMENTARY SCHOOL AND IS IN MISS KLEIN'S CLASS. I ASKED HIM WHAT TYPE OF GRADES HE GOT AND HE SAID SOME "A'S" AND "B'S" AND ONCE IN A WHILE HE GETS AND "F". MIKE SAID HE KNOWS THE DIFFERENCE BETWEEN TELLING A LIE AND TELLING THE TRUTH.

I ASKED MIKE TO TELL ME WHAT HE DID TODAY, BEGINNING WITH WHEN HE GOT UP THIS MORNING. HE TOLD ME HE IS ON SPRING BREAK FROM SCHOOL, SO HE GOT UP TODAY AT ABOUT 9:00 A.M. HE SAID HIS PARENTS HAD ALREADY LEFT FOR WORK AND THEY USUALLY LEAVE AROUND 5:00 A.M. HIS BROTHER PETER WAS ALREADY UP WHEN MIKE AWOKE. MIKE TOOK A SHOWER AND WATCHED TV UNTIL SOME TIME AROUND 11:00 A.M. WHEN HE WALKED DOWN TO HIS FRIEND MIKE FLEMM'S HOUSE. ONCE AT MIKE FLEMM'S HOUSE THEY PLAYED VIDEO GAMES FOR APPROXIMATELY ONE HOUR. I ASKED MIKE IF ANYONE ELSE WAS WITH THEM AT MIKE FLEMM'S HOUSE AND HE SAID YES. HE THEN EXPLAINED THAT MIKE FLEMM'S OLDER BROTHER DAVID, WHO IS FIFTEEN YEARS OLD, WAS ALSO THERE. MIKE ALSO TOLD ME HIS BROTHER PETER CAME OVER TO MIKE FLEMM'S ABOUT TWENTY MINUTES AFTER HE GOT THERE.

MIKE SAID PETER WAS BLEEDING FROM THE SIDE OF HIS HEAD SO HE GRABBED THE PHONE AND YELLED TO THE LADY ON THE OTHER END TO GET HIS DAD. HIS DAD CAME ON THE LINE AND TOLD MIKE TO CALL 911. AT THIS POINT I TOLD MIKE I HAD RECEIVED INFORMATION THERE WAS AN ARGUMENT AT HIS HOUSE AND I WANTED TO KNOW WHAT THAT WAS ABOUT. MIKE TOLD ME PRIOR TO PETER GETTING SHOT HE WAS YELLING AT PETER. HE SAID THAT PETER AND MIKE FLEMM HAD GONE INTO PETER'S ROOM AND THEY WOULD NOT LET HIM IN. HE RELATED THAT WHEN HE TRIED TO OPEN THE DOOR HE FOUND PETER'S TOY BOX HAD BEEN SHOVED UP AGAINST IT. HE SAID THAT FLEMM WAS PLAYING THE DRUMS AND PETER WAS ON THE BED. IT WAS THEN THAT HE WAS YELLING AT PETER TO LET HIM IN AND PETER WAS YELLING BACK TO STAY OUT OF HIS ROOM. I ASKED WHY FLEMM AND PETER WOULD HAVE GONE INTO THE BEDROOM WITHOUT HIM AND MIKE TOLD ME HE DIDN'T KNOW WHY. HE SAID THE ARGUMENT TOOK PLACE BEFORE PETER WAS HURT AND HE AND PETER HAVE OFTEN ARGUED IN THE PAST.

I THEN ASKED MIKE ABOUT THE BEER BOTTLE CAPS THAT WERE LYING IN THE LIVING ROOM AND THE BEER BOTTLES IN THE TRASH CONTAINER IN THE KITCHEN. MIKE FLATLY TOLD ME NONE OF THEM WERE DRINKING BEER. HE SAID HIS PARENTS DRANK THE BEER LAST NIGHT AND THE BOTTLE CAPS WERE LEFT ON THE FLOOR. IT SHOULD BE NOTED THAT MIKE DID NOT SMELL AS IF HE HAD CONSUMED ANY BEER AND DID NOT ACT LIKE HE HAD BEEN DRINKING.

I ASKED MIKE IF THEY HAD SHOT THE PELLET GUNS IN THE PAST AND HE SAID THEY HAD. I ASKED HIM IF HIS PARENTS ALLOWED THEM TO SHOOT THE GUNS AT HIS HOUSE. MIKE BECAME VISIBLY UPSET AND SAID NO, HIS DAD WOULD NOT ALLOW THAT AND HE KNEW THEY WERE ALL IN BIG TROUBLE FOR HAVING THE GUNS OVER THERE. I ASKED MIKE IF THAT WAS WHY HE TOLD MIKE FLEMM TO GET THE GUNS OUT OF THE HOUSE AND WHY HE ORIGINALLY SAID PETER WAS HURT WHILE WRESTLING. HE SAID YES, AND THAT MIKE FLEMM WOULD NOT HAVE SHOT AT PETER IF HE KNEW THE GUN WAS LOADED. MIKE SAID THEY BOTH THOUGHT THE GUN WAS UNLOADED.

IT SHOULD BE NOTED THAT SEVERAL TIMES DURING THIS INTERVIEW MIKE STARTED TO CRY AND ASK HOW HIS BROTHER WAS. I TOLD HIM I HAD NOT HEARD AND I WOULD MAKE SURE HE WAS TAKEN TO THE HOSPITAL AS SOON AS I FINISHED TALKING WITH HIM. BECAUSE MIKE WAS AT HOME BY HIMSELF, AND HIS INFORMATION WAS CRUCIAL TO THIS INVESTIGATION, I CHOSE NOT TO TELL HIM HIS BROTHER HAD DIED AS A RESULT OF HIS HEAD WOUND.

ON 4-2-96 AT 5:55 P.M., I INTERVIEWED MICHAEL FLEMM WHILE IN THE INTERVIEW ROOM AT DESERT HORIZON PRECINCT, 302 EAST UNION HILLS. PRESENT DURING THIS INTERVIEW WAS MIKE FLEMM, MIKE'S FATHER, DAVID FLEMM, AND I. PRIOR TO THIS INTERVIEW I HAD SPOKEN WITH MR. FLEMM WHILE OUTSIDE HIS RESIDENCE AT 18613 NORTH 13TH DRIVE. I HAD EXPLAINED TO MR. FLEMM WE WERE IN THE PROCESS OF SECURING A SEARCH WARRANT FOR HIS RESIDENCE AND WE WOULD BE LOOKING FOR THREE PELLET TYPE GUNS. HE TOLD ME HE KNOWS HIS OLDER SON DAVID HAD AT LEAST TWO PELLET GUNS AND HE BELIEVED THEY WERE BOTH PRESENTLY ON THE COUCH IN HIS LIVING ROOM. I TOLD MR. FLEMM I NEEDED TO TALK TO HIS SON MIKE ABOUT THIS INCIDENT AND I WOULD PREFER TO DO IT SOMEWHERE OTHER THAN IN THE BACK SEAT OF A PATROL CAR. I ASKED HIM IF THEY WOULD MIND COMING TO DESERT HORIZON STATION FOR THIS INTERVIEW. MR. FLEMM TOLD ME THAT WOULD BE FINE. HE AND HIS SON MIKE WERE THEN TRANSPORTED TO 302 EAST UNION HILLS BY OFFICER SHRINER #3276. ONCE AT DESERT HORIZON STATION I HAD MR. FLEMM AND MIKE COME INTO AN INTERVIEW ROOM WITH ME. I EXPLAINED TO THEM I WAS IN CHARGE OF INVESTIGATING THE INCIDENT EARLIER TODAY AND I HAD TALKED WITH SEVERAL PEOPLE AND OBTAINED THEIR SIDE OF WHAT HAPPENED. I TOLD THEM I NEEDED TO TALK WITH MIKE TO GET HIS SIDE OF THE STORY. I ALSO TOLD THEM I WAS GOING TO TAPE RECORD MY INTERVIEW OF MIKE. I THEN PLACED MY RECORDED ON THE TABLE IN FRONT OF MIKE AND I BEGAN READING MIKE HIS JUVENILE MIRANDA WARNINGS. AS I READ THESE WARNINGS MIKE ANSWERED YES TO EACH QUESTION AS TO UNDERSTANDING HIS RIGHTS, AND REQUESTED HIS FATHER BE PRESENT DURING THE INTERVIEW. MIKE AND HIS FATHER AGREED MIKE WOULD WAIVE HIS RIGHT TO REMAIN SILENT. THE FOLLOWING IS A SUMMARY OF THIS TAPE RECORDED INTERVIEW.

MIKE TOLD ME HE IS TWELVE YEARS OLD AND IN SIXTH GRADE AT DESERT WINDS ELEMENTARY SCHOOL. HE IS IN MRS. KELLER'S CLASS AND MAKES MOSTLY "A'S" AND "B'S" AS GRADES. I ASKED MIKE IF HE KNEW THE DIFFERENCE BETWEEN RIGHT AND WRONG AND TELLING THE TRUTH AND A LIE AND HE SAID YES.

I ASKED MIKE TO TELL ME WHAT HE DID TODAY, STARTING WITH WHEN HE AWOKE THIS MORNING. MIKE SAID HE GOT UP THIS MORNING AT ABOUT 8:15 A.M. HE SAID HIS BROTHER DAVE AND HE WERE THE ONLY TWO AT HOME. THREE OF THEM TOOK THE PELLET GUNS OVER TO MIKE AND PETER'S AND SHOT THEM IN THE BACK YARD. I ASKED MIKE WHO THE GUNS BELONGED TO AND HE SAID HIS BROTHER DAVID. HE SAID HIS BROTHER DID NOT KNOW HE TOOK THE GUNS. MIKE DESCRIBED THE GUNS AS TWO LONG RIFLES AND A LITTLE BLACK PISTOL. HE SAID ONE RIFLE HAD A CO2 CARTRIDGE IN IT, BUT IT WAS NOT WORKING BECAUSE THEY DID NOT HAVE A CARTRIDGE INSIDE. THE OTHER RIFLE HAD RED PAINT ON THE BARREL. HE SAID THE TWO RIFLES PUMPED UP. WHEN THEY TOOK THE GUNS TO MIKE AND PETER'S HOUSE, MIKE BRAUN CARRIED THEM IN A BLUE ROBE. HE SAID MIKE BROUGHT THE ROBE WITH HIM FROM HIS HOUSE. MIKE FLEMM SAID HE TOLD MIKE BRAUN TO GO BACK AND GET THE ROBE SO THEY COULD HIDE THE GUNS AS THEY WENT DOWN THE STREET.

FLEMM CONTINUED BY SAYING THAT THE THREE OF THEM SHOT THE GUNS IN BRAUN'S BACK YARD AT SOME PEGS THEY HAD TAPED ONTO THE FENCE. HE SAID HE WAS SHOOTING THE GUN WITH THE CO2 CARTRIDGE AND MIKE AND PETER WERE SHARING THE OTHER TWO. I ASKED MIKE IF HE WAS ALWAYS SHOOTING THE CO2 ONE AND HE SAID YES, HE DIDN'T THINK MIKE AND PETER SHOT IT. HE THEN SAID PETER MIGHT HAVE SHOT IT, WHEN PETER WENT OUT BACK BY HIMSELF. I ASKED MIKE IF THEY DID ANYTHING WHILE INSIDE THE HOUSE AND HE SAID THEY HAD SCRAMBLED EGGS AND WATCHED TV A LITTLE BIT.

MIKE ALSO STATED HE AND PETER WENT INTO PETER'S ROOM AND HE WAS PLAYING THE DRUMS. HE SAID PETER WANTED TO GET THE GUNS AND BRING THEM INTO PETER'S ROOM AND THEN SNEAK OUT THE WINDOW WITH THEM. HE SAID PETER WANTED TO SNEAK DOWN TO HIS (MIKE FLEMM'S) HOUSE AND LEAVE MIKE BRAUN BEHIND. FLEMM SAID PETER PUT HIS TOY BOX IN FRONT OF HIS BEDROOM DOOR SO HIS BROTHER COULDN'T GET IN. PETER THEN OPENED THE WINDOW BUT FLEMM SAID THEY COULDN'T SNEAK OUT BECAUSE THEY DIDN'T HAVE THE BLUE ROBE WITH THEM. AT THAT POINT MIKE BRAUN STARTED PUSHING ON THE DOOR AND YELLING TO LET HIM IN. PETER WAS YELLING BACK AT HIS BROTHER NOT TO COME INSIDE HIS BEDROOM. ONCE MIKE GOT INTO THE ROOM THEY CONTINUED TO YELL AT EACH OTHER. THEY ALL LEFT PETER'S ROOM AND PETER GOT ON THE PHONE TO ASK PERMISSION TO GO OVER TO A FRIEND'S HOUSE. FLEMM TOLD ME HE THOUGHT ALL THE GUNS WERE UNLOADED BECAUSE THEY SHOT THEM ALL OFF. HE SAID MIKE BRAUN GRABBED THE RIFLE WITH THE CO2 CARTRIDGE AND CHECKED IT. HE SAID MIKE PULLED THE "THING" BACK AND LOOKED IN, THEN SAID NOTHING WAS IN THERE. I ASKED FLEMM WHY MIKE BRAUN WOULD HAVE EVEN LOOKED IN THE RIFLE AND HE SAID, "CAUSE HE DIDN'T WANT TO SHOOT HIS BROTHER WITH A BB." I ASKED WHY MIKE BRAUN WOULD THINK HE WOULD SHOOT HIS BROTHER AND FLEMM SAID "BECAUSE THEY WERE SHOOTING." I ASKED FLEMM TO EXPLAIN THAT TO ME. HE THEN SAID THAT AFTER MIKE SAID THE GUN WAS EMPTY, HE PICKED IT UP AND SAID "I'M GONNA SCARE PETER, WATCH." I ASKED FLEMM TO TELL ME HOW MIKE BRAUN CHECKED THE RIFLE TO SEE IF IT WAS UNLOADED. HE SAID MIKE PULLED THE BOLT BACK AND LOOKED IN. HE SAID MIKE PULLED THE BOLT BACK A COUPLE OF TIMES AND SAID THERE WAS NOTHING IN THERE. MIKE FLEMM TOLD ME HE TOOK THE GUN AND SAID "OKAY, I'M GONNA SCARE YOUR BROTHER, WATCH." HE SAID HE THOUGHT THE GUN ONLY HAD AIR IN IT AT THAT TIME. HE THEN POINTED THE GUN AT PETER AND PULLED THE TRIGGER. FLEMM SAID THE NEXT THING HE KNEW, PETER'S EAR STARTED BLEEDING.

I ASKED FLEMM IF PETER HEARD HIS STATEMENT ABOUT "SCARING YOUR BROTHER"

AND HE SAID NO, BECAUSE HE WAS ON THE PHONE. I ASKED FLEMM HOW FAR AWAY FROM PETER HE WAS WHEN HE SHOT THE GUN. HE SAID THE BARREL OF THE RIFLE WAS ABOUT TWO OR THREE FEET AWAY FROM PETER'S HEAD. I ASKED HIM IF MIKE BRAUN KNEW HE WAS GOING TO SCARE PETER AND HE SAID NO. I THEN ASKED HIM WHY MIKE BRAUN WOULD EVEN LOOK IN THE GUN. FLEMM THEN SAID HE HAD TOLD MIKE HE WAS GOING TO SCARE PETER, BEFORE MIKE LOOKED TO SEE IF THE GUN WAS UNLOADED. I ASKED FLEMM WHAT HE THOUGHT WAS GOING TO HAPPEN WHEN HE PULLED THE TRIGGER AND HE SAID, "I THOUGHT AIR WAS COMING OUT." HE SAID HE POINTED THE RIFLE IN THE AREA AROUND PETER'S RIGHT EAR. HE STATED PETER'S EAR STARTED BLEEDING AND MIKE GOT ON THE PHONE WITH HIS DAD, WHO TOLD MIKE TO CALL 911. I ASKED FLEMM IF MIKE BRAUN TOLD HIS DAD THAT PETER HAD BEEN SHOT WITH THE BB GUN AND HE SAID NO. I ASKED HIM WHY AND HE SAID MIKE DIDN'T WANT TO GET INTO TROUBLE. FLEMM SAID HE STARTED RUNNING AROUND AND WAS TOTALLY NERVOUS AND SCARED. HE SAID THAT MIKE TOLD HIM TO LEAVE, SO HE WRAPPED THE GUNS IN THE BLUE ROBE AND TOOK THEM TO HIS HOUSE AND PUT THEM ON THE COUCH. HE THEN RAN BACK TO MIKE AND PETER'S TO GET HIS BICYCLE. AS HE WAS RIDING HIS BIKE BACK TOWARDS HIS HOUSE A POLICE OFFICER STOPPED HIM.

AT THIS POINT I ASKED FLEMM IF THEY HAD SHOT AT ANYTHING ELSE BESIDES THE POGS. HE SAID THEY SHOT AT A BIRD ONCE. I THEN ASKED HIM WHAT HE KNEW ABOUT THE BEER BOTTLE CAPS ON THE FLOOR IN THE LIVING ROOM. HE SAID THE CAPS WERE ON THE FLOOR WHEN HE GOT THERE. HE SAID THEY HAD NOT BEEN DRINKING. FLEMM SAID I COULD CHECK WITH MIKE BRAUN'S DAD ABOUT THE BEER BOTTLE CAPS. IT SHOULD BE NOTED THAT MIKE FLEMM DID NOT HAVE AN ODOR OF BEER ON HIM NOR DID HE ACT AS IF HE HAD BEEN DRINKING.

I ENDED THIS INTERVIEW BY ASKING FLEMM IF HE TRIED TO HURT PETER ON PURPOSE. HE SAID, "NO. I NEVER EVEN WANTED TO HURT HIM AT ALL. I DIDN'T WANT TO HURT HIM IN ANY WAY." I ASKED WHAT HE THOUGHT WAS GOING TO HAPPEN WHEN HE AIMED THE GUN AT PETER AND PULLED THE TRIGGER. HE SAID "I THOUGHT HE WAS JUST GOING TO JUMP BACK AND SAY WHOA, WHAT THE HECK." MIKE TOLD ME MIKE BRAUN HAD TOLD HIM THE GUN WAS NOT LOADED AND HE THOUGHT IT WAS UNLOADED. HE SAID HE WOULDN'T POINT THE GUN AT SOMEONE IF HE KNEW IT WAS LOADED.

IT SHOULD BE NOTED THAT I DID NOT TELL MIKE FLEMM OR HIS FATHER THAT PETER BRAUN HAD DIED PRIOR TO THIS INTERVIEW. I LATER CONTACTED MR. FLEMM AND ADVISED HIM OF PETER'S DEATH.

ON 4-3-96 AT 1000 HOURS I ATTENDED VICTIM PETER BRAUN'S AUTOPSY AT THE MARICOPA COUNTY MEDICAL EXAMINER'S OFFICE. THIS PROCEDURE WAS PERFORMED BY DOCTOR JULIE A. BROWN. THE VICTIM'S BODY WAS SEALED IN A WHITE BODY BAG. THE BODY HAD BEEN ORGAN HARVESTED WHILE AT ST. JOSEPH'S HOSPITAL.

I OBSERVED A ENTRANCE WOUND IN THE VICTIM'S RIGHT EAR. THIS WOUND WAS LOCATED JUST ABOVE THE OPENING TO THE AUDITORY CANAL. X-RAYS SHOWED A PROJECTILE IN THE LEFT PROTION OF THE BRAIN. DOCTOR BROWN REMOVED A SINGLE PELLET FROM THE LEFT FRONTAL LOBE OF THE BRAIN AND I RETAINED THIS ITEM AS EVIDENCE. THERE WAS NO ABRASION RING AROUND THIS ENTRANCE WOUND. THIS PELLET PENETRATED THE SKULL AND TRAVELED RIGHT TO LEFT THROUGH THE BRAIN.

DOCTOR BROWN TOLD ME THE CAUSE OF DEATH WAS A GUNSHOT WOUND TO THE HEAD AND THE MANNER OF DEATH WAS A HOMICIDE.
