SUMMARY OF MEETING:

Representatives from the CSMA requested a meeting to discuss their comments on the proposed changes to the PPPA test protocols (CP94-1-20). The companies updated the Commission staff on activities since the last meeting held on May 5, 1994. Company representatives indicated that they were starting to evaluate their product lines and contact various suppliers for "senior friendly" packaging. Several companies indicated that new designs and ideas were being considered, however, much time and money was necessary for development.

The main concern voiced by the members was the proposed effective date. In the comments they had suggested an advisory panel be formed to evaluate a phase in program for the various substances.

The staff indicated that all comments were being considered. The staff also believes that the effective date is the most important issue and is looking at several options including those submitted by commenters. The staff stated that the information for the final rule is scheduled to go to the Commission in December 1994.
