Statement of Work

Purchase of Portable FTIR

1. Description of Services: The Consumer Product Safety Commission (CPSC), Laboratory Sciences requires a portable Fourier-transform Infrared Spectrometers (FTIR). The FTIR must be capable of screening for phthalates to quickly identify potential non-compliance with the Consumer Product Safety Improvement Act. Units must be portable and designed to detect phthalates in plastic at concentrations at less than or equal to 1%, as well as in higher concentrations.

2. Description of Work: The following requirements must be met:

- a. Spectral range from 650 to 4000 cm^{-1} , at minimum.
- b. Wavenumber resolution of 4 cm^{-1} , or better.
- c. Detection limit of 1% or better for measuring phthalates in a variety of plastic matrices.
- d. Instrument must be capable of running off battery power and external power supply. Battery power alone must operate the instrument for at least 2 continuous hours. Battery must be rechargeable. AC power cable must be standard North American 15 or 20 A and 125 V.
- e. All components necessary for field operation (system, computer {if external}, power supply, etc.) must weigh no more than 15 lbs. System must have a handle and/or come in carrying case for transport.
- f. System must be able to export data to a Windows PC or portable media (such as a USB flash drive or SD card) in .JPEG or .SPC format, or other format compatible with Microsoft Office software.
- g. Minimum of one year full warranty, including parts, labor, and travel.
- h. Firmware and software updates to improve performance are included for lifetime of instrument.
- i. Instrument must be new and a model in current production. Refurbished or demonstrator instruments not acceptable.

User Interface (UI) Specifications:

- a. UI should include a user mode in which it relays results in a format similar to “Pass/Fail/Uncertain” in regards to the presence of detectable levels of phthalates without user interpretation required.
- b. UI should automatically compare results to a spectral database, and when possible, display the type of plastic and plasticizer (or other appropriate information).
- c. UI should notify user when background spectrum needs to be taken.
- d. UI should include an “Expert mode.” “Expert” functions must include adding spectrum and identity to library for future reference, viewing the raw spectrum, and searching the spectral library.
- e. Computer memory must be able to save data internally, with simple function to export one or multiple spectra.
