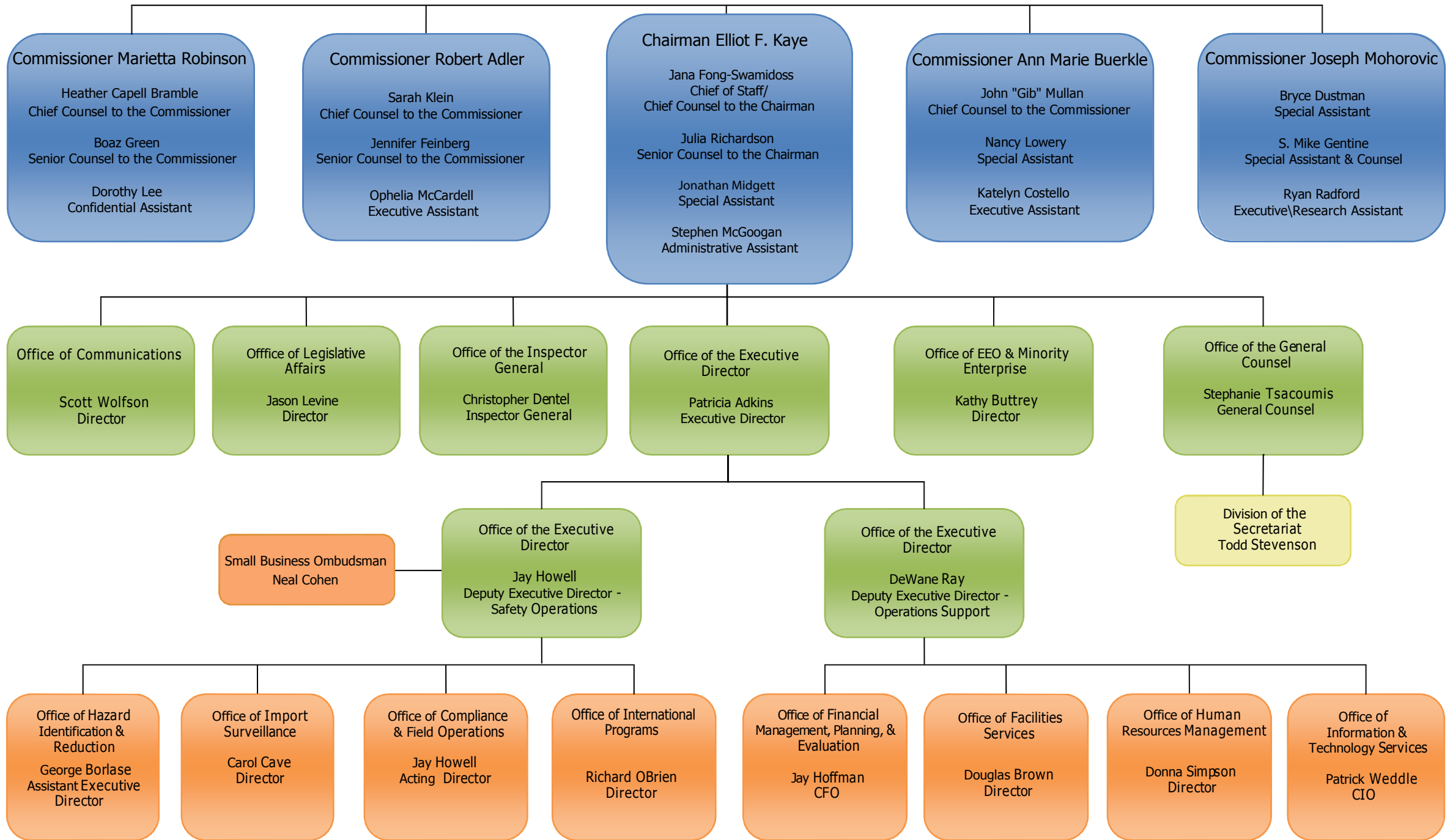


# U.S. Consumer Product Safety Commission Organizational Chart
