### Summary of Meeting

The meeting was chaired by Mr. John Blair representing ASTM F15 on Consumer Products. After discussion of the hazards to be addressed, it was decided that both "regulation" and portable goals might be addressed in the standard and that issues of durability as well as tipover were of concern. Assignments were made to revise various portions of the draft performance standard.

In addition, it was decided that the CPSC guidelines would be amended as necessary and balloted as an ASTM guideline.

A revised draft standard and a revised guideline will be circulated to the attendees for their comment. If there are numerous comments or issues that require a meeting to resolve, a meeting will be held, with March as a tentative date at this time. If there are few comments, the standard and guideline will be balloted without another meeting of the group.
