Dear Mr. Baltes:

This letter is in response to your correspondence of December 17, 1976 concerning a cigarette filter which broke and fell into your mouth. Your letter was forwarded to the Consumer Product Safety Commission (CPSC) by the Department of Justice. We apologize for the delay in responding to your letter.

The Consumer Product Safety Commission has responsibility for administering several statutes including the Consumer Product Safety Act (CPSA) and the Federal Hazardous Substances Act (FHSA). Section 3(a)(1)(B) of the CPSA excludes from the Commission's jurisdiction under the CPSA tobacco and tobacco products. Similarly, section 2(f)(2) of the FHSA, as amended, excludes tobacco and tobacco products from Commission jurisdiction under the FHSA. In our view, the legislative history of these exclusions makes it clear that Congress intended that the Commission not regulate any hazards associated with cigarettes. For example, the provision in the Senate version of the amendments to the statutes administered by the Commission that would have authorized the Commission to regulate cigarettes as an ignition source was deleted from the final bill. Therefore, we are unable to take any action in regard to your complaint.

While the views expressed in this letter are based upon the most current interpretation of the law by this office, they could subsequently be changed or superseded by the Commission. Please do not hesitate to contact me if you have further questions regarding this matter.

I fully intend to pursue this matter further.
