SUMMARY OF MEETING: This meeting, related to the participants requests to the Commission that certain parts of their products be excluded from the CPSIA lead limits, discussed lead content of specific components of bicycles and similar products. The industry discussed the requirement for lead in metal alloys for certain functional purposes and other technical reasons, and European requirements for motor vehicles that allow use of lead up to specified maximum limits. The participants also mentioned an evaluation conducted on their behalf that indicates that children would not experience significant lead exposure from use of the products.
