The China Product Hazard Monthly Summary Bulletin advises Chinese manufacturers of the most commonly occurring hazards posed by products they produce, such as batteries including lithium-ion batteries and other electrical/electronic products, violations of U.S. flammability standards for children's sleepwear, excessive lead levels in children's products, small parts choking hazards, and others. 22-768	The infant bath seats fail to meet the U.S. federal safety standard for infant bath seats, including requirements for stability and leg openings, and can tip over while in use, posing a drowning hazard to babies. 嬰兒浴座 不符合美國聯邦包括穩定和腿距的嬰兒浴座安全標準,使用中會翻倒,對嬰兒構成溺水危害。
22-215	The jogging stroller's rear disc brakes have openings that can cause amputation
