5. Clothing Strings

Purpose - To develop a new ASTM voluntary safety standard to reduce strangulation and entanglement hazards associated with drawstrings on children's clothing

Highlights -

- o In 1/95, the ASTM Drawstrings on Children's Clothing Subcommittee (ASTM F15.37), which was established 9/17/94, approved the use of ASTM fast track provisional standard-setting procedures to expedite development of a safety standard
- o After three meetings, the subcommittee issued a ballot of a provisional standard in 4/95. In a 5/3/95 letter to the ASTM subcommittee members, CPSC staff expressed concern that the draft standard did not eliminate drawstrings in the neck area of children's outerwear garments. Staff also recommended that the standard include requirements to address drawstrings at the waist and bottom of upper outerwear garments.
- o At a 6/2/95 subcommittee meeting, negative votes requesting the elimination of drawstrings were ruled non-persuasive, and the ballot was withdrawn on the basis that technical requirements for "safer" drawstrings could be developed and a greater level of consensus could be achieved.
- o A revised provisional standard was balloted in 8/95 CPSC staff notified all subcommittee members that (1) the CPSC staff continued to oppose the use of drawstrings at the neck area of children's upper outerwear and (2) the staff was in agreement with the inclusion of requirements to address vehicular dragging hazards associated with waist and bottom drawstrings of upper outerwear.
- o The 8/95 ballot failed and at a subcommittee meeting on 9/22/95, a task group was formed to explore the possibility of having an independent testing laboratory develop safety requirements to address clothing string hazards.

6. Ranges and Ovens

Purpose - To revise both the UL standard for electric ranges (UL 858) and the ANSI standard for gas ranges (ANSI Z21.1) to reduce the number of cooking-related fire injuries and deaths.

Highlights -

- o In 2/95, CPSC signed an Interagency Agreement (IAG) with the National Institute for Standards and Technology (NIST) to: (1) identify the physical characteristics associated with imminent cooking fires and (2) identify sensing devices with the potential to sense those characteristics.
- o In 6/95, members of industry and voluntary standards organizations attended a demonstration of the NIST testing.
- o In 9/95, the NIST report on their research effort to identify the physical characteristics associated with imminent cooking fires neared completion.
- Subsequent to the completion of Phase I research, NIST will begin Phase II of this work. Sensing devices will be tested for their potential to: (1) sense the characteristics identified in Phase I, (2) detect a pre-ignition condition, and (3) warn of approaching ignition.

7. Shock Protection Devices (GFCIs)

Purpose - To improve the Standard for Ground-Fault Circuit-Interrupters (GFCIs), UL 943, by identifying installation and reliability issues which may affect the proper operation of GFCIs and by revising the standard accordingly.

Highlights - The following activities were undertaken to address installation errors associated with receptacle-type GFCIs:

- o Effective 7/4/95, GFCI load terminals were required to be covered with a warning label explaining that load terminals are to feed additional receptacles only. Instructions describing how to differentiate "Line" from "Load" conductors and how to determine whether the GFCI has been wired properly were also required.
- The National Electrical Manufacturers Association (NEMA) previously volunteered to oversee development of improved installation instructions. The results of the study conducted by CPSC staff to determine consumer behavior during GFCI installation are being used by NEMA in the development of the instructions. In 7/95, CPSC staff met with NEMA to review proposed new installation instructions. Testing by NEMA is planned in 1996.

8. Smoke Detectors

Purpose - To revise the Standard for Single and Multiple Station Smoke Detectors (UL 217) to improve the reliability and remove impediments to essential consumer maintenance practices.

Highlights -

- o CPSC staff met with the UL Industry Advisory Council on 1/24/95 and presented specific recommendations for improvements to the UL standard. The recommendations included:
 - (1) Require a means to silence the alarm so consumers will not permanently disable the smoke detector,
 - (2) Standardize mounting plates and electrical connections to alleviate problems that consumers experience in replacing and mounting the detector,
 - (3) Include markings on the detector to identify the date of manufacture so that consumers can replace detectors at the appropriate time intervals,
 - (4) Require an acoustic signal frequency range so that elderly adults can hear the detector's alarm.
 - (5) Improve the dust, smoldering, and corrosion tests to better replicate the household environment.
 - (6) Create a survivability test to ensure smoke detectors will survive the early stages of fire,
 - (7) Require critical components in the detector to meet reliability specifications.
- o UL formally responded to the recommendations on 5/30/95 and indicated they would propose some of the recommendations to the fifth edition of the standard and consider the others.
- o CPSC staff will continue participation with UL, industry and other interested parties during meetings to discuss the proposed recommendations. In addition, staff will continue to work with UL to modify the standard to include proposals for all the recommendations.

9. Baby Walkers

Purpose - To review and revise the existing voluntary standard for walkers (ASTM F977-89) in accordance with the ASTM requirement for a 5-year review and to advocate additional performance requirements to address the hazard of children falling down stairs in walkers.

Highlights -

- o Background Existing Standard The voluntary standard for infant walkers contains performance requirements addressing tip overs and structural failure. Falls down stairs are currently addressed by a warning label on the product. The existing standard is in the 5-year review process required by ASTM.
- o A subcommittee ballot of a revision to the entire ASTM walker standard closed on 3/26/95. Three negative votes were discussed at a 3/29/95 walker section meeting and two were ruled persuasive, including one about the stair-warning label. Changes to the standard in response to these negative votes were discussed and issues resolved at a 6/9/95 meeting The proposed revisions were balloted to the subcommittee in 9/95.
- Background Performance Requirements to Address Stair-Falls In 12/94, manufacturers representing a significant portion of the sales of traditional walkers formed an ASTM working group to accomplish the technical work necessary to develop new performance requirements to address the stair-fall hazard. At the 6/9/95 meeting the technical working group provided an initial draft of the new performance requirements for discussion.

10. Water Heaters, Gas

Purpose - To revise the ANSI gas water heater standard (ANSI Z21.10) in order to eliminate or reduce ignition of flammable vapors by residential gas water heaters.

Highlights -

- o Significant progress was made by industry during 1995 toward developing a voluntary standard to eliminate the risk of ignition of flammable vapors.
- Industry formed a Joint Product Development Consortium to evaluate and test all possible technical solutions to the problem. Consortium activities are proprietary at this time, but the Consortium is briefing the CPSC staff regularly and work is on schedule and progressing

- o Work has begun to develop a test protocol for submittal to the ANSI water heater subcommittee for inclusion in the ANSI water heater standard. A sophisticated test facility has been constructed. Shakedown testing has been successfully completed on the facility. Test method verification is awaiting delivery of new technology water heaters from the Consortium.
- o The Gas Research Institute (GRI) has increased funding for this project from \$800,000 to \$1,400,000.
- o The GRI is addressing the CPSC staff's concerns and is investigating a "worst case" test method

B. Other Significant Activities

During 1995, the staff monitored and advocated safety improvements in 30 additional voluntary standards activities. These included new voluntary standards activities which were instated at the request of CPSC staff. A few highlights follow:

- o On 1/10/95, ANSI approved a revised national consensus standard on hardwood plywood which provides limits on formaldehyde emissions.
- o The ASTM toy safety standard was revised on 1/15/95 to provide for improved safety features dealing with flammability tests, toxicology, protrusions on crib toys, small parts, labeling, battery operated toys, and miscellaneous items such as clarification of test procedures for riding toys. Additional safety provisions, including those relating to pre-school play figures and pompons, were in the voting process at the end of 1995.
- o An ANSI Canvas Committee was established to develop a national consensus safety standard for **blind cords**.
- o A revision of the ASTM stroller standard (ASTM F833) was approved in 3/95 which added requirements addressing entrapment in leg openings and inadvertent collapse of certain umbrella style strollers.
- o The National Electrical Code for 1996 was approved on 5/25/95 and provides safety features for electric heat tape, spas/hot tubs and GFCI's.
- o UL proposed major improvements to its Christmas-tree lights standard (UL 588) which become effective 1/97.

- o The revised ANSI safety standard on (electric) cord sets and power-supply cords was approved on 5/26/95 and maintains a minimum six foot length for extension cords.
- o A revised ASTM standard on playground surfacing was approved on 8/15/95 which provides new safety requirements for impact tests on fasteners or anchoring devices used on manufactured mats that may have less than optimal shock attenuation characteristics.
- o A new ASTM provisional standard with consumer safety specifications for toddler beds was approved on 8/22/95. Work continues on a full standard, while the provisional standard remains in effect
- o On 8/30/95, ASTM established a subcommittee (ASTM F15.38) to develop a national consensus safety standard for window guards.
- o On 8/31/95, ASTM initiated a new group (ASTM F15.39) to develop a national consensus safety standard on bean bag chairs.
- o ANSI interim safety provisions for **20lb. gas grills** were superseded by final provisions which become effective on 10/1/95. These provisions provide for leak and overpressure protection.

Also during the reporting period, the CPSC staff worked with national consensus voluntary standards coordinating groups to improve consumer product safety. Highlights of these activities follow:

- o ASTM further expedited the standards development process by permitting simultaneous voting at the Committee and Society levels. At a minimum, this should save several months in the approval process.
- o UL responded to CPSC staff's request to further open the standards development process by announcing a new program whereby Technical Advisory Panels (TAPs) will include CPSC staff at the earliest stage of a UL consumer product safety standard's development.
- o ANSI asked its standards developers to speed adoption of critical standards by using fast track procedures to develop "Draft Standards For Trial Use".
- o ANSI's Consumer Interest Council proceeded with its priority project to improve conformance to consumer product safety standards. This involves a market research study to determine the causes of why safety standards are or are not used and the identification of specific ways to enhance the use of safety standards

- The CPSC voluntary standards conformance monitoring program on wooden bunk beds was completed. Over 250 letters were mailed to those believed to be manufacturers and importers of bunk beds in order to determine the degree of conformance to the ASTM bunk bed safety standard. Twenty-five companies which manufactured, imported, or sold wooden bunk beds with potential entrapment hazards were requested to provide immediate corrective action. The results of these activities were provided to the Commission during 1995.
- o The CPSC staff performed tests on backyard playsets to determine the extent of conformance to the ASTM national consensus safety standard. A meeting with manufacturers was held in 9/95 to review final testing results.

Voluntary Corrective Action Plans And Product Recalls

Voluntary Corrective Action Plans and Recall of Products
Subject to Product Safety Standards and Other Specific Regulations
Exclusive of Section 15 of the Consumer Product Safety Act

The Office of Compliance and Enforcement and the Regional Offices are jointly responsible for identification of consumer products that fail to comply with a specific product safety standard or other CPSC product-related requirements mandated by statute or regulation. CPSC works cooperatively with the responsible companies to obtain voluntary corrective action plans monitored by the commission during Fiscal Year 1995.

Consumers may find products on the market that resemble those appearing on this list. After manufacturers and importers correct violations, they may distribute complying versions of products which were recalled. CPSC monitors recalls to ensure that the noncomplying products have been removed from the market. It is unfair to responsible manufacturers and importers to conclude that toys and children's products on the list are still offered for sale.
