SUMMARY OF MEETING:

CMP 17 met to create Second Draft revisions for the 2020 NEC based on consideration

of Public Comments on the proposed 2020 *NEC* First Draft. CMP 17 covers *NEC* Articles 422 (Appliances), 424 (Fixed Electric Space Heating Equipment), 426 (Fixed Outdoor Electric Deicing and Snow-Melting Equipment), 427 (Fixed Electric Heating Equipment for Pipelines and Vessels), 680 (Swimming Pools, Fountains, and Similar Installations) and 682 (Natural and Artificially Made Bodies of Water). CMP 17 acted on 141 public comments and also developed and approved panel revisions. Proposed Second Draft revisions that the Panel accepted by simple majority at the meetings will be voted on by CMP 17 members by electronic ballot subsequent to the meetings (CPSC staff does not vote). Public comments that were rejected by CMP 17 during the meeting are final and are not balloted.
