SUMMARY OF MEETING:

CMP 17 convened by video conference to create Second Draft revisions for the 2023 *NEC* based on consideration of public comments on the 2023 *NEC* First Draft. CMP 17 covers *NEC* Articles 422 (Appliances), 424 (Fixed Electric Space Heating Equipment), 426 (Fixed Outdoor Electric Deicing and Snow-Melting Equipment), 427 (Fixed Electric Heating Equipment for Pipelines and Vessels), 680 (Swimming Pools, Fountains, and Similar Installations) and 682 (Natural and Artificially Made Bodies of Water). CMP 17 acted on 64 public comments and also developed and approved additional revisions based on comments. Proposed Second Draft revisions that the Panel accepted by simple majority at the meetings will be voted on by CMP 17 members by electronic ballot subsequent to the meetings (CPSC staff does not vote). Public comments that CMP 17 rejected during the Second Draft meetings are not balloted.
