Summary of Meeting:

This Scope TG meeting for ASTM F15.19 on Wearable Infant Blankets was led by Chris Gulbrandsen. The discussion focused on resolving negatives for definitions in the balloted standard, F15.19 (23-03) Item 001 WK81176 - Standard Consumer Safety Specification for Wearable Blankets & Swaddles Intended for Use by Infants and Toddlers. Specifically, members debated whether the term "wearable" helps distinguish swaddle products with fasteners from loose blankets intended for swaddling; based on a straw poll, members voted to remove the term "wearable" from the list of definitions.

At the February 14, 2024 subcommittee (SC) meeting, the Scope TG was asked to come up with definitions for both "weighted" and "non-weighted" under Section 3.19, filling material. At the Scope TG meeting, concerns continued to be expressed regarding use of the term "intentionally" when referring to weighted fill. Members also stated avoiding organic fill materials is unnecessarily broad given that it only needs to exclude fill that can grow mold or expand in the presence of water. While members agreed these concerns are valid, members expressed that there is currently no need to define "filling material" and their subtypes given that there are no performance requirements that are specific to filling materials. Based on a straw poll, the TG deleted the 3.19 definition for filling material and moved it to the task group's memory sheet to revisit at such time as performance requirements are proposed. CPSC staff questioned what the implications are for defining weighted and non-weighted products given the standard is no longer defining weighted in 3.16 and filling material is no longer defined in 3.19 (weighted products are currently defined based on the type of fill material).

Given that weighted infant sleep products would still need to meet requirements for wearable blankets and swaddle products, members questioned if we still need definitions for weighted subtypes in Sections 3.17 and 3.18. Members recommended the TG refer the question back to the SC for discussion given the substantive nature of the question. The same recommendation to refer back to SC was given when CPSC staff questioned whether separate warnings for weighted and non-weighted products were still needed. A member stated separate warnings for weighted products are not needed as a bullet point and can be added to both wearable



blankets and swaddles to discontinue use if filling is liberated (similar hazard for fiberfill, feathers, etc.).
