Brief summary of significant agency activities that will continue during a lapse:

Continuation of certain agency activities to identify, screen, interdict, recall, and warn against violative and hazardous consumer products that arrive at the ports, those products that have entered the country illegally, and other violative and hazardous consumer products, is necessary to prevent imminent threats to the safety of the American public. During a lapse in appropriations, the following excepted activities will continue to the extent they involve the imminent threat to human life or the protection of property: monitoring and analyzing reports of incidents of product injuries and fatalities from hospital emergency departments, manufacturers and consumers to identify hazardous products that pose an imminent threat to human life; conducting takedowns of banned hazardous products, negotiating recalls or issuing public safety warnings for products that pose an imminent threat to human life; interdicting consumer product shipments with a known high risk of containing dangerous or violative products at the U.S. border to prevent entry of products that pose an imminent risk to safety; coordination, activities, and preparations related to the agency's Performance Budget Request and President's Budget; Office of Inspector General (IG) hotline and other IG activities requiring immediate attention; and other required operations to support exempt and excepted activities. Providing legal advice on excepted activities, the Antideficiency Act, and other legal matters pertaining to the lapse in appropriations, and filing, prosecuting, or defending legal actions with respect to products that create an imminent threat to the safety of human life. Excepted activities will be assessed throughout the appropriations lapse for potential changes to imminent threats to human life or protection of property.

Brief summary of significant agency activities that will cease during a lapse:

During a lapse in appropriations, the following activities are among those that will not be performed unless they are performed by an employee who is not funded by general appropriations (absent an imminent threat to the safety of human life): rulemaking and voluntary standards activities; payments to certain vendors and non-exempt employees; contracting; information and education efforts to consumers regarding Safe Sleep practices, drowning prevention, toy safety and other safety hazards; civil penalties; stakeholder education; responding to congressional requests; audit activities; responding to FOIA requests; employee relations activities; and travel that is not necessary to prevent imminent threats to the safety of the American public.
