

## What We Do

CPSC is charged with protecting the public from unreasonable risks of injury or death associated with the use of the thousands of types of consumer products under the agency's jurisdiction. Deaths, injuries, and property damage from consumer product incidents cost the nation more than \$1 trillion annually. CPSC is committed to protecting consumers and families from products that pose a fire, electrical, chemical, or mechanical hazard. CPSC's work to ensure the safety of consumer products – such as toys, cribs, power tools, and household chemicals – contributed to a decline in the rate of deaths and injuries associated with consumer products over the past 40 years.

We work to reduce injuries and death rates using analysis, regulatory policy, compliance and enforcement, and education to identify and address product safety hazards. This includes:

- Hazard identification and assessment
- Voluntary standards and mandatory regulations
- Import surveillance
- Compliance and enforcement
- Public outreach
- Intergovernmental coordination
- Cooperation with foreign government

CPSC is committed to being an effective and impactful force for consumer product safety in order to achieve our vision of a nation free from unreasonable risk of injury and death from consumer products.
