Furthermore, the information was in the public interest, as it was in previous budget justifications. If you are withholding information, this budget would withdraw CPSC from its independence and make it a HHS agency. Changing the structure of an agency without congressional approval is illegal and unconstitutional. The Reorganization Act of 1939 explicitly states that reorganizing a government agency requires congressional approval. Bypassing Congress is illegal.
