Summary of Meeting:

On November 7, 2024, CPSC staff hosted a hybrid meeting to discuss possible amendments to 16 CFR part 1632, Standard for the Flammability of Mattresses and Mattress Pads and 16 CFR part 1633 Standard for the Flammability (Open Flame) of Mattress Sets. There is an open advanced notice of proposed rulemaking (ANPR) to amend or revoke the standard ([70 Fed. Reg. 36357](#)). Mr. Ryan Trainer, President of the International Sleep Products Association (ISPA) and Mr. Brent Larson from Element presented remarks about possible candidates for an updated ticking substitution test method for both standards. Lisa Scott of the Directorate for Laboratory Sciences presented a case study to highlight a few known irregularities with the ticking substitution provisions in section 1632.6 and the effect on flammability performance for both standards. A collaborative discussion followed with stakeholders sharing their own experiences and perspectives on evaluating ticking materials and alternate test methods.

Next Steps:

Staff will review the feedback received and prioritize next steps. A future meeting with stakeholders is likely, but not yet scheduled.
