Notice of Proposed Rulemaking to Establish a Safety Standard for OHV Debris

Penetration Hazards; Notice of Extension of Comment Period

AGENCY: Consumer Product Safety Commission.

ACTION: Extension of comment period.

SUMMARY: On July 21, 2022, the Consumer Product Safety Commission (Commission or CPSC) published in the *Federal Register* a notice of proposed rulemaking (NPR) to promulgate a consumer product safety standard to address debris penetration hazards in recreational off-highway vehicles (ROVs) and utility terrain or utility task vehicles (UTVs). The NPR invited the public to submit written comments during a 60-day comment period, beginning on the NPR publication date, and ending on September 19, 2022. In response to a request for an extension of the comment period, the Commission is extending the comment period to October 28, 2022.

DATES: Submit comments by October 28, 2022.

SUPPLEMENTARY INFORMATION:

On May 18, 2022, CPSC staff forwarded a briefing package to the Commission, recommending issuance of an NPR to establish a safety standard for ROV and UTV debris penetration hazards. On June 22, 2022, the Commission voted to publish an NPR in the *Federal Register*, to promulgate a consumer product safety standard for ROV and UTV debris penetration hazards. The NPR published on July 21, 2022, with a 60-day comment period, which closes on September 19, 2022. 87 FR 43688.

On August 22, 2022, Greg Knott, Vice President, Standards & Regulatory Affairs,

Outdoor Power Equipment Institute (OPEI), submitted a request to the Commission to extend the

comment period until October 28, 2022. OPEI circulated a draft of the OPEI B71.9 revision

proposal by email on August 3, 2022, which includes a proposal for debris penetration. OPEI

requests more time to be able to discuss CPSC staff's evaluation of OPEI's proposed test

methods and to prepare comments for the rulemaking record accordingly.

The Commission has considered this request to extend the comment period. To provide

sufficient time for stakeholders to discuss test results and prepare comments for the rulemaking,

the Commission will grant an extension of the comment period to October 28, 2022.

SUBJECT: Evaluation of request to extend comment period for Notice of Proposed

Rulemaking (NPR) to Establish a Safety Standard for OHV Debris Penetration

Hazards

Introduction

On August 22, 2022, Greg Knott, Vice President, Standards & Regulatory Affairs, Outdoor Power Equipment Institute (OPEI), submitted a request to the Commission to extend the comment period for the Notice of Proposed Rulemaking to Establish a Safety Standard for OHV Debris Penetration Hazards from September 19, 2022, to October 28, 2022.

Staff's evaluation

OPEI's stated justification for its request for an extension of the comment period is to obtain feedback from CPSC's technical staff on the debris penetration test method that was shared with CPSC staff at a voluntary standard meeting on June 7, 2022, and it included in a draft revision of ANSI/OPEI B71.9 that was circulated on August 3, 2022, to canvass members of the voluntary standard. However, the request for comment in the NPR seeks comment, data, views, or arguments on the rule as proposed by the Commission. Technical input from CPSC staff on a different set of proposed requirements for the B71.9 voluntary standard is not necessary for OPEI to provide comment on the Commission's proposed rule. In any event, CPSC technical staff will be considering the draft revision to B71.9 as a canvass member and will provide technical feedback to OPEI on the debris penetration test method when it submits its ballot vote at the proper time. This feedback will become part of the rulemaking record.

Delaying the close of the comment period would likely delay the delivery of a final rule, because

Recommendation

Based on the factors discussed in staff's evaluation, staff recommends that the Commission deny OPEI's request for an extension of the comment period of the OHV NPR because it has not been justified and would delay the rulemaking.
