## ITEM:

Petition CP 18-1: Petition for Inflatable Head Protective Devices (Briefing package dated August 21, 2019, OS# 4951)

## **DECISION**:

The petitioner withdrew the petition by notifying the Secretary of the Commission and individual Commissioners via electronic mail message before a majority vote was reached. The Commission voted 2-2-1. By email, dated September 16, 2019 (4:56 p.m.), Nancy A. Nord, of OFW Law and counsel for the petitioner, Hovding Sweden AB withdrew the petition (see attached email). The petition was filed with the Commission on December 15, 2017.

Commissioners Feldman and Commissioner Baiocco voted to deny the petition and direct staff to draft a letter of denial to the petitioner.

Commissioner Adler and Commissioner Kaye voted to take other action as follows: Grant the petition in part and commence rulemaking under 5 U.S.C. § 553 to propose to amend the bicycle helmet standard 16 C.F.R. Part 1203, to allow the use of inflatable helmets that meet appropriate safety-based performance requirements. The staff shall propose requirements that are substantially the same as SP-method 4439 unless staff determines that additional or different requirements are necessary to address the likelihood of serious injuries and death to bicyclists resulting from impacts to the head.

Acting Chairman Buerkle abstained from the vote. (The Acting Chairman did not submit a vote before withdrawal of the petition and the 5 pm voting deadline.)
