

## U.S. CONSUMER PRODUCT SAFETY COMMISSION WASHINGTON, D.C. 20207

Record of Commission Actions Commissioners Voting by Ballot Placed in the Record at Open Commission Meeting October 20, 1994

At the October 20, 1994, meeting of the U.S. Consumer Product Safety Commission, the staff briefed the Commission in open session on issues related to the Commission's Operating Plan for Fiscal Year 1995. No decision were made.

Chairman Ann Brown convened today's meeting, with Commissioner Mary Sheila Gall present.

<u>Ballot Vote Decisions</u>. The following decisions made by ballot vote of the Commissioners were placed in the record.

1. <u>Requests for 60- and 90-Day Extensions of the Comment Period on the ANPR</u> for Baby Walkers from Juvenile Products Manufacturers Association (JPMA) and Graco Children's Products, Inc. (Ballot due 10/6/94)

The Commission voted unanimously (2-0) to extend the comment period by 45 days. Chairman Brown filed a statement concerning her vote in this matter, copy attached.

2. <u>Proposed Civil Penalty Settlement: Gund, Inc., crib mobiles, CPSC Docket</u> <u>No. 95-C0001</u> (OS# 4374) (Ballot due 10/12/94)

The Commission voted unanimously (2-0) to provisionally accept the settlement agreement and order containing a civil penalty in the amount of \$150,000. Unless a commenter asks the Commission not to accept the Settlement Agreement and Order within 15 days after publication in the <u>Federal Register</u>, the Agreement and Order will be deemed finally accepted on the 16th day.

3. <u>Proposed Civil Penalty Settlement: Bee International. Inc., toys, CPSC Docket</u> No. 95-C0002 (OS# 4883) (Ballot due 10/12/94)

The Commission voted unanimously (2-0) to provisionally accept the settlement agreement and order containing a civil penalty in the amount of \$65,000. Unless a commenter asks the Commission not to accept the Settlement Agreement and Order within 15 days after publication in the <u>Federal Register</u>, the Agreement and Order will be deemed finally accepted on the 16th day.

4. <u>Proposed Consent Agreement In the Matter of Chattern, Inc., child-resistant</u> packaging, CPSC Docket No. 94-1 (OS # 5070) (Ballot due 10/13/94)

The Commission voted unanimously (2-0) to approve issuance of an Order accepting the Consent Agreement in this matter, thereby concluding the adjudicative proceeding initiated on October 15, 1993.
