The March 4, 1981 meeting of the Consumer Product Safety Commission was convened in open session by Acting Chairman Stuart Statler. Commissioners R. David Pittle, Edith Sloan, and Sam Zagoria were present.

Ballot Vote Decisions: The Chairman placed into the record the following decisions made by ballot vote of the Commission since the last open meeting of the Commission.

1. Consent Order Agreement: the Gillette Co., doing business as Braun North America

By unanimous vote (4-0) the Commission provisionally accepted a Consent Order Agreement in this matter involving certain Braun coffeemakers.

2. Corrective Action Plan: A-Bee Syndicate, Inc. (ID 79-187), B & D Molded Products, Inc. (ID 80-08), and Injectron Corporation (ID 80-23)

By unanimous vote (4-0) the Commission accepted the corrective action plan in this matter involving certain table lamps.

3. Change of Employment: Member of the National Advisory Committee for the Flammable Fabrics Act

By unanimous vote (4-0) the Commission decided that the change in employment of NAC/FFA member Margaret Henry does not affect her status as a consumer representative on the committee, and that she may remain a member through the end of her term in September, 1982.

4. Consent Order Agreement: Samor Broome Corp. and Joseph Kahn

By unanimous vote (5-0) the Commission accepted a Consent Order Agreement in this matter under the Flammable Fabrics Act.

5. Consent Agreement Order: Lafayette Junior Moore and Carpet Specialists

By unanimous vote (4-0) the Commission provisionally accepted the Consent Agreement in this matter under the Flammable Fabrics Act.

6. Change of Employment: Member of the Product Safety Advisory Council

By unanimous vote (4-0) the Commission decided that the change of employment of PSAC member Kathie Mabie-Klass does not affect her status as a government representative on this advisory committee and that she may remain a member through the end of her term in September, 1981.

7. Asbestos General Order: Extension of Time for Submission of Information

By unanimous vote (4-0) the Commission granted several requests and extended to March 20, 1981, the deadline for submission of information in response to CPSC's general order concerning consumer products containing asbestos. The deadline had been February 20, 1981.

8. Special Order and Subpoena for Documents Concerning TRIS (OS #905)

By unanimous vote (4-0) the Commission approved a staff request to issue a Special Order and Subpoena in a matter concerning TRIS-treated children's sleepwear.

The staff then in open session briefed the Commission on (1) final stockpiling rule and a petition to extend the effective date for gas-fired space heaters and (2) the proposed miniature Christmas tree light standard. In closed session the staff briefed the Commission on issues it considers recommending assessment of a civil penalty.

There being no further business on the agenda, Acting Chairman Statler adjourned the meeting.
