Dear Mr. Huestis:

The Consumer Product Safety Commission has been investigating possible hazards associated with the "Low Temperature Leak Detector" also referred to as "Blue Leak Detector" sold by the L.P. Gas Equipment, Inc. To date, the Commission has been unable to obtain sales and distribution information relating to these leak detectors.

Accordingly, the Commission has decided to issue the attached subpoena, pursuant to section 27(b)(3) of the Consumer Product Safety Act, which specifies the information required.

It should be noted that failure to respond to the subpoena at the time specified therein may, pursuant to section 27(c) of the Act, lead to entry of a court order directing compliance with the Commission's subpoena.

Other parts of the Consumer Product Safety Act provide for additional sanctions. Section 19(a)(3) prohibits any person from failing or refusing to make reports or provide information required under the Act. Section 20 of the Act provides for the imposition of civil penalties computed on a daily basis, and section 22 provides for injunctive sanctions against any person who knowingly violates section 19 of the Act. Section 21 of the Act, moreover, provides for criminal penalties of fine and imprisonment under certain circumstances.

SUBPOENA AD TESTIFICANDUM and SUBPOENA DUCES TECUM

To assist the Consumer Product Safety Commission in its investigation of possible hazards associated with the "Low Temperature Leak Detector" also referred to as "Blue Leak Detector" sold by L.P. Gas Equipment, Inc. project no. 541091, you are hereby directed as authorized by Sec. 27(b)(3), of the Consumer Product Safety Act 15 U.S.C. 2076(b)(3) to appear before the Commission's Hearing Officer John F. Rabusch at Room 650, Federal Building, Fort Snelling, Twin Cities, Minnesota 55111 on November 8, 1974. The purpose of your appearance is to give testimony on the gas leak detector described herein.

You are further directed to bring with you for submittal to the Commission two copies of the materials specified below:

Records relating to the sale and distribution of a product known as "Low Temperature Leak Detector" also referred to as "Blue Leak Detector" by L.P. Gas Equipment, Inc. in eight and sixteen-ounce containers, one-gallon containers, and unlabeled containers, from March 5, 1973 through September 27, 1974. The term "records" includes but is not limited to sales invoices, customers purchase orders, shipping memoranda, bills of lading and other related documents, including memoranda of telephone calls and other oral communications:

.The corporate charter of L.P. Gas Equipment, Inc.;

Corporate documents showing the names and addresses of present officers of L.P. Gas Equipment, Inc.;

The last annual statement of L.P. Gas Equipment, Inc.;

All complaints and reports of fire or personal injury associated with gas leaks which may have been caused by deterioration of gas lines or gas line couplings on which a "Low Temperature Leak Detector" or "Blue Leak Detector" was used. The term "reports" includes but is not limited to all physical forms of: Correspondence, letters, telegrams, photographs, files, memoranda, including memoranda of telephone calls and other writing prepared by any person or persons, including those by insurance firms, investigators, laboratories and researchers; and includes both originals and copies whether or not sent or received.
