Certificate Data Elements for eFiling

Identification of the finished product

Each consumer product safety rule to which the finished product has been certified

Date when the finished product was manufactured

Place where the finished product was manufactured, produced, or assembled

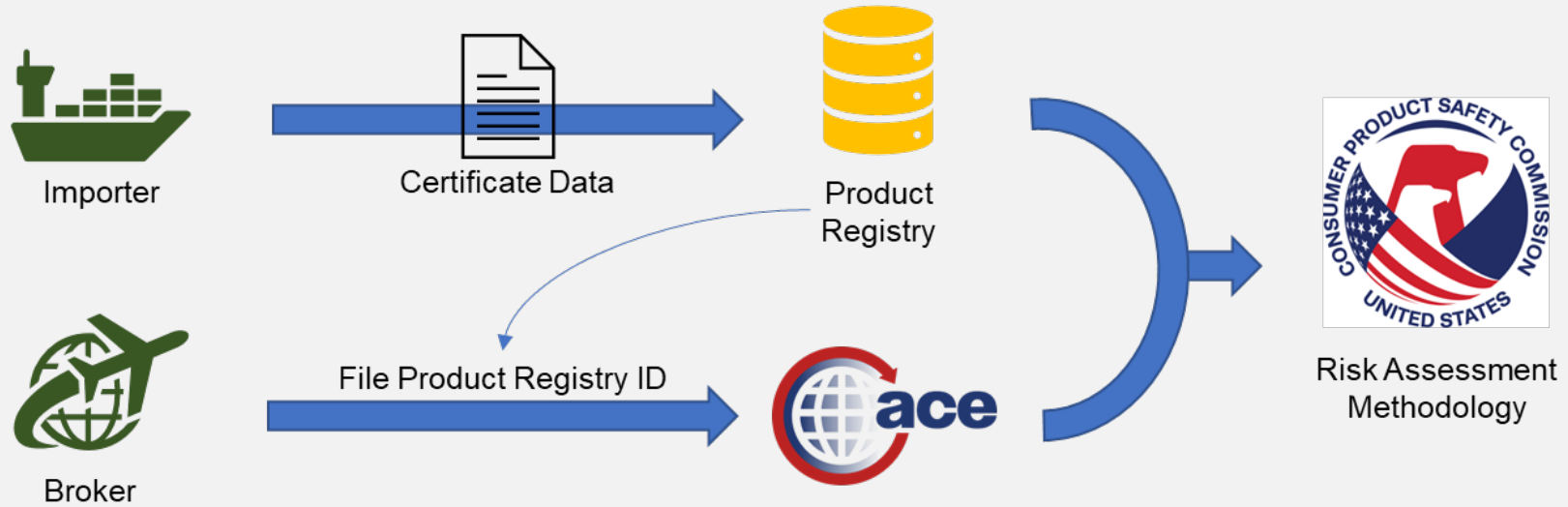
Date when the finished product was most recently tested for compliance

Parties on whose testing a certificate depends

A check box indicating that a required certificate currently exists for the finished product

eFiling Trade Industry Benefits

1	 Shorter Review Clock	<ul style="list-style-type: none">• Beta Pilot participants will benefit from a shorter 2-Way Messaging Clock• Air and Truck Shipments: 4 business hours after entry is filed• Ocean Shipments: 8 business hours after entry is filed
2	 Reduction in Risk Score	<ul style="list-style-type: none">• Beta Pilot participants may see a reduction of their risk score over time based on the amount of data provided• Reductions in Risk Scores may result in reduced hold times and fewer exams which may reduce costs to the importer
3	 No Disruptions to Operations During the Pilot	<ul style="list-style-type: none">• Normal operations will continue with no extra scrutiny or holds during the Beta Pilot• If an exam is needed during the Beta Pilot, participants' holds will be prioritized

eFiling Trade Industry Benefits

**Greater Focus
on Higher Risk
Products**

- CPSC's increased focus on higher risk shipments will **result in fewer holds to check for certificates**
- Holds will be more likely **performed for substantial violations** rather than for certificates as certificate data will be provided ahead of time
- Fewer holds may result in **reduced costs to the importer**

**Access to CPSC
Staff During
the Pilot**

- CPSC Staff will be readily available **to answer product regulation questions** during the Beta Pilot

**Inform
Rulemaking**

- Feedback provided by participants during the Beta Pilot **will be used to inform rulemaking** for full implementation of eFiling

Role of Importers

Importers play an essential role in the success of the eFiling process through the **oversight and filing** of their data for testing in the Beta Pilot. Specific importer responsibilities are highlighted below:



Identify a broker partner, if not a self-filer



Work with broker partner to identify CPSC regulated products that will be included in the Beta Pilot



Manage certificate data in an electronic format that can be transmitted into the Full Message Set or the Product Registry with broker support

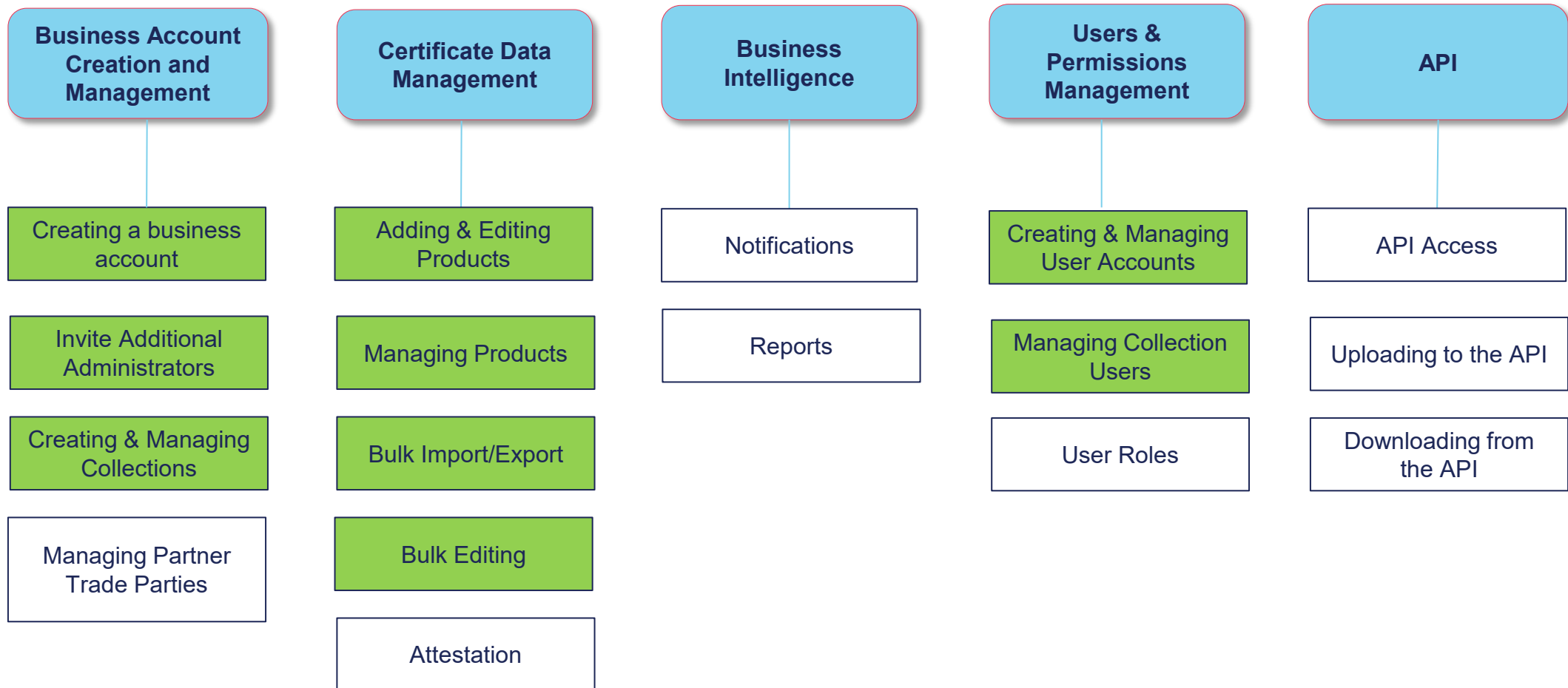
CPSC is actively consulting with a **working group comprised of 9 importers** to inform the development of the eFiling Product Registry

Product Registry Working Group

- Comprised of 9 importers (and their broker/industry partners) who are also participants in the Beta Pilot
- Participate in bi-weekly IT development meetings to provide iterative feedback on the development of the Product Registry including:
 - System Requirements
 - Functionality
 - Data Elements
- Test the integration of the Product Registry to their internal systems which will serve as a blueprint for the remaining Beta Pilot participants

The bi-weekly IT development meetings are posted to the CPSC calendar and are open to the public to join and listen in on the discussion
