CPSC reported on incidents of children falling off of changing pads, specifically children pushing with their heels and falling out the top of a changing pad, rather than over the raised sides. Alternative warning labels were presented and the wording favored by the CPSC was selected. Comments on the proposed stability test draft should be forwarded to J. Preston by July 15th.
