## COMPLAINT COUNSEL'S APPLICATION FOR THE ISSUANCE OF SUBPOENAS ON NON-PARTIES KEVIN BRINKMAN, PATRICK BASS, AND JURRIEN VAN DEN AKKER

Pursuant to 16 C.F.R. § 1025.38, which requires the issuance of a subpoena to any non-party for the purpose of compelling attendance, testimony, and production of documents at a hearing or deposition, Complaint Counsel respectfully requests that the Presiding Officer forward, and that the Commission issue, the three subpoenas submitted concurrently with this Application.

The non-parties named in the subpoenas are: (1) Kevin Brinkman; (2) Patrick Bass; and, (3) Jurrien van den Akker. Kevin Brinkman is the former thyseenkrupp Access Corp. ("TKA") Vice President of Engineering and former National Wheel-O-Vator Vice President of Engineering (that was merged into TKA). Patrick Bass is the former CEO and President of thyssenkrupp North America and Executive Vice President Research and Development Americas for thyssenkrupp Elevator. Jurrien van den Akker is a former TKA President.

Based upon discovery conducted thus far, Complaint Counsel believes that these three non-parties have critical, relevant information regarding the residential elevators at issue in this matter ("Subject Products"), including, but not limited to, information regarding the engineering

drawings and instructions, including installation, design and planning guides, incident information related to the Subject Products, and information about consumers' interactions with the residential elevators. Among other things, Kevin Brinkman had experience at TKA and its predecessor National Wheel-O-Vator, and may have relevant information concerning Respondent's interactions with other residential elevator firms concerning safety. Brinkman and Bass also participated in the American Society for Mechanical Engineers A17 Residence Elevator Committee, as the Committee was evaluating whether a five-inch gap was adequate, inconsistencies in measuring between the hoistway door and the elevator car door, and issues with accordion door deflection as alleged in paragraphs 85–90 of the Complaint. This relates to the defects alleged in the Complaint. See Compl. ¶ 40–65. Finally, Jurrien van den Akker, among other things, was the signatory of a 2014 letter to residential elevator dealers that detailed the entrapment hazard and the potential space guard safety device option, and Complaint Counsel believes he has relevant information concerning the Respondent's homeSAFE program.

Accordingly, Complaint Counsel requests that the Presiding Officer forward this Application and the subpoenas to the Commission for appropriate action.<sup>1</sup>
