**RESPONDENT’S APPLICATION FOR THE ISSUANCE OF A SUBPOENA ON  
NON-PARTY ROBERT S. ADLER**

Pursuant to 16 C.F.R. § 1025.35(b)(2), which requires the issuance of a subpoena to any non-party for the purpose of taking a deposition, and 16 C.F.R. § 1025.38, Respondent TK Access Solutions Corp., formerly known as thyssenkrupp Access Corp. (“Respondent”), through the undersigned counsel, respectfully requests that the Presiding Officer forward, and that the Commission issue, the subpoena submitted concurrently with this Application.

The non-party named in the subpoena is Robert S. Adler. Mr. Adler is a former Commissioner of the U.S. Consumer Product Safety Commission (“CPSC” or “agency”) who served in that capacity from approximately August 18, 2009, through approximately December 1, 2021, including serving as Acting Chair of CPSC from approximately December 1, 2013, through approximately July 28, 2014 (during which time CPSC closed its 2013 investigation into the elevator components manufactured by Respondent for installation by trade professionals) and again from approximately October 27, 2019, through approximately October 7, 2021 (during which time CPSC issued the Complaint).

In his capacity as a Commissioner, Mr. Adler was responsible for the oversight of CPSC activities. 15 U.S.C. § 2053. In his capacity as Acting Chair, Mr. Adler was “the principal executive officer of the Commission, and he [exercised] all of the executive and administrative functions of [CPSC], including . . . the appointment and supervision of [and] the distribution of business among personnel appointed and supervised by the Chairman and among administrative units of the [CPSC].” 15 U.S.C. § 2053(f). As such, Mr. Adler has direct knowledge of CPSC’s policies and practices, its handling of this matter, and the facts surrounding this action, including, but not limited to, the agency’s 2017 denial of a petition seeking adoption of a mandatory rule governing residential elevators and agency staff’s statement that they “could not identify any specific elevator models or manufacturers whose installations revealed design defects or installation defects that caused a substantial product hazard resulting from an excess space gap between the car door and hoistway [door].” TKAS\_CPSC21-1\_51511.

Additionally, documents produced by Complaint Counsel, CPSC\_21-1\_024693-94, suggest that Mr. Adler held at least one direct, private, previously undisclosed meeting with representatives of the law firm of Cash, Krugler & Fredericks, LLC, in or about 2013, regarding residential elevator components. As such, Mr. Adler has unique knowledge of the facts and circumstances surrounding the instigation of the 2013 investigation, which the agency subsequently closed without action during his first tenure as Acting Chair. Thus, the information Mr. Adler possesses is not only relevant to this matter, but it is also likely that Respondent would not have access to the requested information absent the issuance of this subpoena as Complaint Counsel advises there are no records of that meeting.

Accordingly, Respondent respectfully requests that the Presiding Officer forward this Application and the subpoena to the Commission for appropriate action.<sup>1</sup>
