ORDER GRANTING STIPULATION AND JOINT MOTION TO SET SCHEDULE FOR LEACHCO TO COMLY WITH DECEMBER 16, 2022 ORDER AND THE DEPOSITIONS OF LEACHCO EMPLOYEES

Following this Court's December 16, 2022, Order, Complaint Counsel moved to compel depositions. *See* Compl. Counsel's Mot. to Compel Depos. or, in the Alternative, Mot. for Leave to Take Depos. (Dec. 21, 2022). The parties subsequently filed a joint motion with a proposed schedule for compliance with the Order. *See* Stipulation and Joint Mot. to Set Schedule for Leachco to Comply with Dec. 16, 2022 Order and the Depos. Of Leachco Employees, at 2 (Dec. 23, 2022).

The joint motion stipulated that Leachco will fully comply with the Order by producing responsive documents and amending its responses no later than January 17, 2023. Joint Mot. at 2. It also set the time and type of deposition for each requested employee, starting on January 31, 2023. *Id.* Complaint Counsel requested its motion to compel depositions be treated as withdrawn without prejudice if the stipulations are adopted. *Id.* at 3.

The Stipulation and Joint Motion is is **GRANTED**, and Respondent is **ORDERED** to comply with the proposed schedule.

Complaint Counsel's Motion to Compel Depositions is therefore **DISMISSED WITHOUT PREJUDICE**.
