CPSC, By Us International Co. Ltd. Announce Recall of Bicycle Components

WASHINGTON, D.C. - In cooperation with the U.S. Consumer Product Safety Commission (CPSC), By Us International Co. Ltd., of Taiwan, is recalling about 13,500 Ballistic front suspension forks installed on certain Brunswick mountain bicycles. The forks on these bicycles can break apart, causing riders to lose control and fall


By Us and Brunswick have received 18 reports of forks on these bicycles breaking resulting in nine riders, including teenagers, suffering serious head and bodily injuries, abrasions, bruises and chipped teeth.

The recalled forks were installed on Mongoose S-20 and MGX S-20 bicycles, which are orange, and the Roadmaster Ridge Rider bicycles, which is red. The forks on these bikes are black with decals that read "BALLISTIC" and "105" on the sides of the suspension fork legs. A senial number is located on the inside of the suspension fork legs. The recall only includes forks with the following senial numbers:



PRODUCT: Wooden Stacking Toys - Jack Rabbit Creations Inc , of Atlanta, Ga., is recalling about 9,000 hand-painted, wooden stacking toys called Stacking King These stacking toys have seven interlocking multi- colored, doughnut-shaped pieces mounted on pegs. The top of the toy has a round, hand-painted face with a wooden yellow crown. A label on the toys packaging reads in part, "Stacking King," "Jack Rabbit Creations" and "Made in China." Specialty and Gift shops have sold these products from February 1999 through April 2000 for about \$25.



PROBLEM The wooden peg in the black and white checked base can come off, presenting a choking hazard to young children

INCIDENTS/INJURIES Jack Rabbit Creations has received four reports of the pegs coming loose. No injuries have been reported.



CPSC, Hangouts Recall Baby Hammocks

PRODUCT Baby Hammocks - Hangouts, of Boulder Colo, is recalling about 350 baby hammocks. The "baby hammocks" are 6-foot-long mini-hammocks. They are woven from thin cotton strings with nylon end strings in solid or multi-striped colors. The label attached to the end loop reads, "Hangouts® from Bellartson" and "Woven by Hand in MEXICO." The Hangout store in Boulder, Colo, and its catalogs sold these hammocks as model number MY-BB-1110 from January 1990 through September 1999 for about \$20.



PROBLEM. These baby hammocks can suddenly become twisted around childrens' necks and strangle them. Also, infants sleeping on soft bedding can become wedged in positions in which they cannot breathe.

INCIDENTS/INJURIES No incidents or injuries have been reported in these hammocks, but between 1984 and 1995, CPSC received reports of 12 deaths of children in other in in-hammocks.

WHAT TO DO Consumers with one of these hammocks should stop using it immediately, and return it to Hangouts for a free, standard single hammock (model MY-SS-1130). For more information, call Hangout at (800) 205-4916 anytime

CPSC, Warner Bros. Studio Store Announce Recall of Tweety Rattles and Sandals

WASHINGTON, D.C - In cooperation with the U.S. Consumer Product Safety Commission (CPSC), Warner Bros. Studio Store, of Burbank, Calif, (Warner Bros. Store) is recalling about 3,800 Tweety rattles and 1,000 pairs of Tweety sandals Both products are being recalled because small parts of each product can detach and pose a choking hazard to young children.

CPSC and Warner Bros. Studio Store have received three reports of parents removing detached parts of sandals and a rattle from their babies' mouths. No injuries have been reported

Rattle Recall

The rattle is sold as part of a Tweety Bib, Rattle and Spoon Set The rattle, which is covered with a yellow cloth and is approximately 5 inches long, is a Tweety image and has a small blue and white bib (about 1.5 inches wide and 1.4 inches long) tied around Tweety's neck Tweety's bib can detach, posing a choking hazard to a young child.

Warner Bros Stores nationwide sold the Tweety Bib, Rattle and Spoon Sets from August 1998 through January 2000 for about \$15.

Sandals Recall

The Tweety sandals are girls' jelly swimwear sandals made of transparent pink plastic with embedded sparkles and a picture on the inside soles of Tweety sitting on flowers. The sandals were sold in infant sizes from 3 to 15 months. The sandals have three round plastic flowers on the top surface. The flowers can detach, posing a choking hazard to a young child.

Warner Bros Stores nationwide sold the sandals from February 2000 through April 2000 for about \$10.

CPSC, Kids II Announce Recall of Bouncer Seats

WASHINGTON, D.C. - In cooperation with the U.S. Consumer Product Safety Commission (CPSC), Kids II of Alpharetta, Ga., is voluntarily recalling about 99,000 bouncer seats for in-home repair. The removable toy bar that attaches to the seat can suddenly release and cause injuries to babies.

Kids II has received 122 reports of toy bars suddenly releasing from bouncer seats, resulting in 31 injuries to babies, including a black eye, a scraped eye, and facial cuts

Only Kids II bouncer seats with semi-circular toy bars are recalled. These bouncer seats were sold under the names "Soft Toy Bouncer Seat" or "Comfort Me Bouncer." The Kids II logo is embroidered on each seat's crotch strap. The bouncer seats have a ruffled seat pad in three patterns, a black, white and red cow print; a teddy bear, rocking horse and toy box print; and a nursery rhyme print. Each pattern has certain model and lot numbers, which are found on a tag attached to the seat. The Comfort Me Bouncers feature vibration and soothing sounds, including music, waves and heartbeat. Each semi-circular toy bar has three toys. Some of the recalled seats came with white toy bar tethers.

Mass merchandise and juvenile specialty stores nationwide sold the seats from October 1997 through April 2000 for about \$25 to \$35

Consumers should remove the semi-circular toy bars immediately and contact Kids II for an in-home repair kit. Consumers can continue to use the bouncer seat for the baby to sit in as long as the toy bar is removed. Consumers should call Kids II toll-free at (877) 325-7056 between 7.30 a.m. and 4.30 p.m. ET Monday through Friday for a free repair kit

Kids II bouncer seats with rectangular shaped toy bars are not subject to this recall.


Infant Cargo Skirts Recalled by Associated Merchandising Corp.



CPSC, Jetmax International Ltd. Announce Recall to Repair Children's Rocking Chairs Sold at Target Stores


WASHINGTON, D.C - In cooperation with the U.S. Consumer Product Safety Commission (CPSC), Jetmax International Ltd, of Stamford, Conn, is voluntarily recalling to repair about 48,000 children's rocking chairs. The rear legs of the chair can separate from the rocker's base causing it to collapse, and the child seated in the chair can fall.

Jetmax has received five reports of these chairs collapsing and children falling. One 13-month-old girl suffered a laceration requiring 18 stitches

Jetmax imported the rocker exclusively for sale by Target stores. The wooden rocking chairs come in two styles: one for boys and one for girls. The boy's rocker has a yellow frame, red rockers (chair bases) and a blue canvas seat. The girl's rocker has a white frame, purple rockers (chair bases) and a pink canvas seat. There is no writing on the chairs, but the packaging reads, "restoreTM & RESTYLE KIDS," "Wooden Folding Chair," "Ages 3 and Up," and "Made in China." The chairs are designed for children between 30 and 100 pounds. They are 23 inches long, 13 inches wide and 16.5 inches high.

Target stores nationwide sold the rocking chairs from November 1999 through March 2000 for about \$20.

CPSC, Vtech Industries Announce Recall of Toy Baby Phone

WASHINGTON, D.C. - In cooperation with the U.S. Consumer Product Safety Commission (CPSC), Vtech Industries LLC, of Wheeling, Ill is recalling about 34,000 toy baby phones. The toy phones have a ball-shaped antenna which can detach, presenting a choking hazard to young children.

CPSC and Vtech Industries have received nine reports of the plastic ball detaching from these phones. One child reportedly started to choke on one of these plastic balls.

CPSC, KinderkidsTM Announce Recall of Inflatable Playrings for Babies

WASHINGTON, D.C. - In cooperation with the U.S. Consumer Product Safety Commission (CPSC), KinderkidsTM, of Lawrence, Kan, is voluntarily recalling about 18,000 inflatable playrings. Babies sit inside the playring, which is used as an activity center and looks like a pool float. When a baby leans his face against the side of the playring, the soft surface covers the baby's nose and mouth, restricting airflow, and posing the risk of suffocation

CPSC has received one report of a 6-month old baby found gasping for air after falling asleep face down in the playring. The baby was removed from the playring without injury CPSC is aware of infant suffocation deaths when their airflow is restricted from contact with soft surfaces.

The recalled playring, which measures 40 inches in diameter, has a yellow, plastic, inflatable, inner tube with a multicolor cloth covering. The cloth covering features eight activities for babies, including a boat rattle, a mirror flower, a soft teether on a puppy's collar, a butterfly, and a squeak ball and fish. A tag on the bottom of the cloth covering reads "Warning!" and "Recommended for children 6 to 18 months" The packaging reads, "Discovery Playring," "MADE IN CHINA" and "Not to be used in water." They are sold with plastic foot pumps for inflating the playrings.

Walmart stores, and One Step Ahead, a mail-order company, sold the playrings from July 1998 though April 2000 for between \$20 and \$35.

Consumers should stop using the playrings immediately and contact Kinderkids for information on how to receive a refund. Consumers should call Kinderkids toll-free at (888) 433-6251 from 9 a m to 4 p m. PT Monday through Friday.






